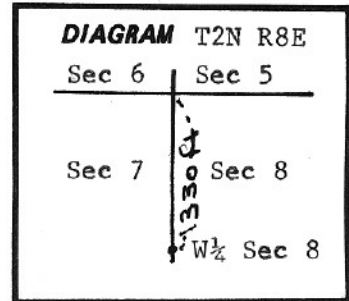
History of original corner establishment:

Wm E. Campbell set a basalt stone 12"X12"X12" 8" in ground marked  $\frac{1}{4}$  on west face, from which:

A fir 45" in dia. bears S 67 E 27 links (17.8 ft.) marked  $\frac{1}{2}$  S BT.

A fir 45" in dia. bears N 58 W 45 links (29.7 ft.) marked  $\frac{1}{4}$  S BT.

In 1897.



Description of corner evidence found:

Found fir stump with blaze 6" above ground and still open. Scribing visible but not legable.

Found stone nereby that measures 12"X10"X8" and marked with a small "X" which may have been used for the corner but does not fit GLO description.

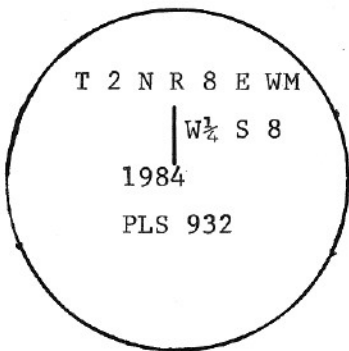
Description of monument and accessories | established to perpetuate the original location of this corner: Set 2½" X 30" aluminum pipe with flared bottom and 3½" cap marked as shown and in a mound of stone.

From Which:

A Doug Fir 24" in dia. bears S43 E 23.9 feet blazed and scribed W¼ S8 BT and posted tree with 54-3 sign.

A Doug Fir 16" in dia. bears S 57 W 20.4 feet blazed and scribed W¼ S8 BT and posted tree with 54-3 sign.

Set plastic post near corner.
