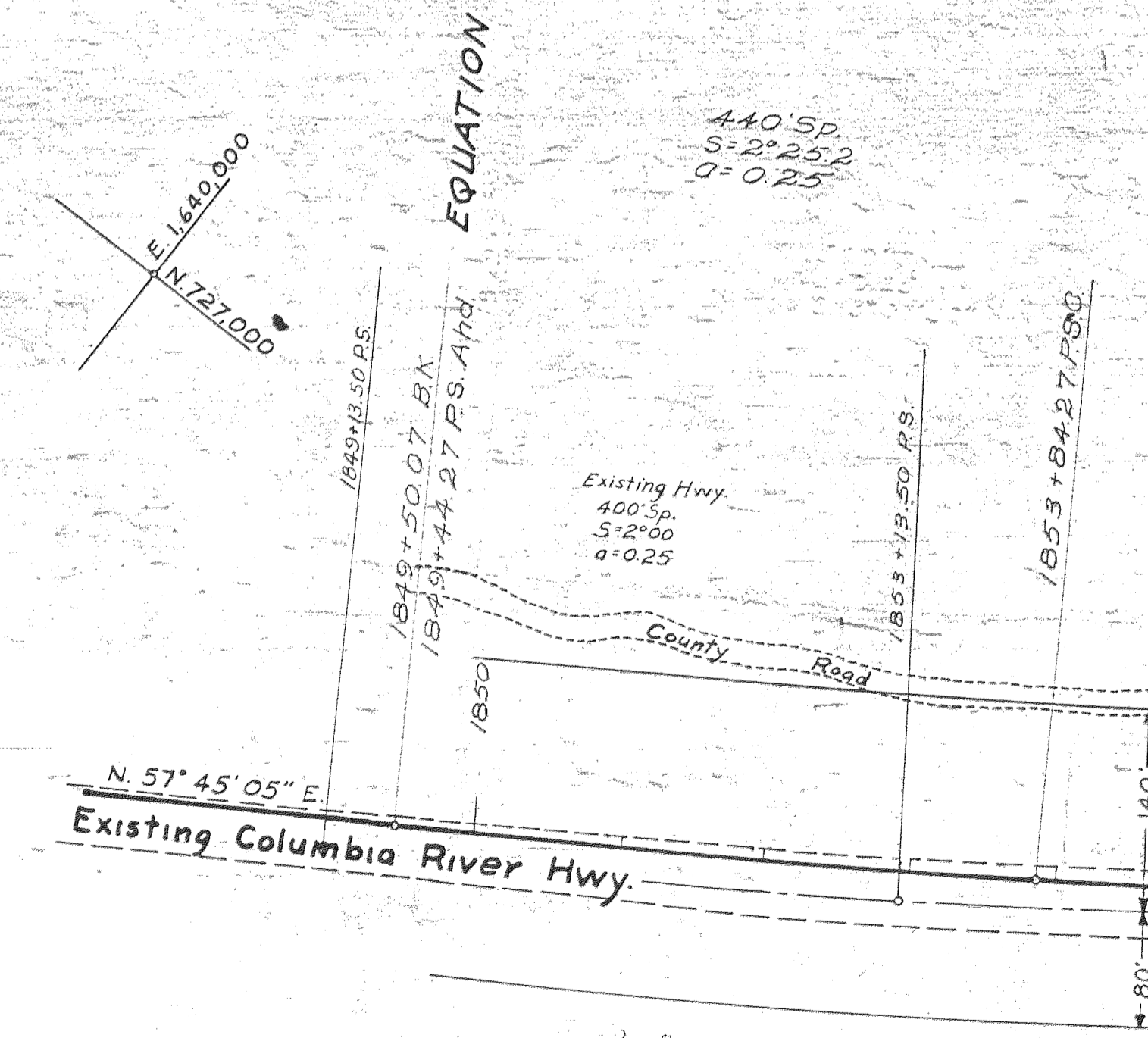

GRID BEARING-NORTH ZONE

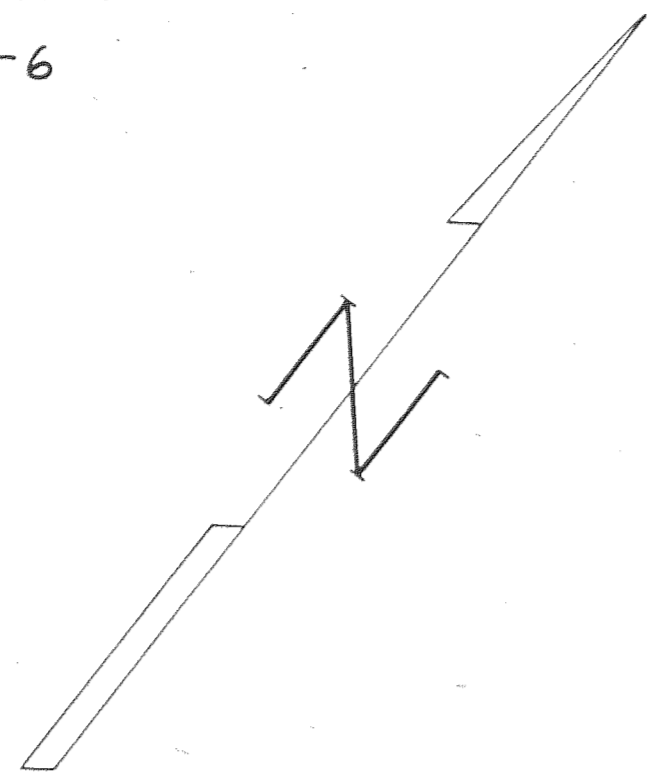
