On March 9, 1981 our firm was retained by Andy Abrams of Parkdale, Oregon to survey a tract of land in Section 19, T. 1 S., R. 10 E., W.M. The intent of the survey was to run the west line of the north one-quarter, and the east-west centerline of the northwest one-quarter. Hood River County Surveyor's office provided a copy of their survey #7574 done in 1975 when this section was partially subdivided.

The survey was started by running a traverse line from the northwest corner of Section 19 to the west one-quarter corner thereof. The northwest corner is a Hood River County brass cap monument. A 12" scribed fir bears N. 60° E., 17.9 feet. A 12" fir bears S. 55° E., 19.4 feet. The west one-quarter corner is a 3/4" iron pipe recovered by Hood River County Surveyor in 1970.

A true line was calculated between these two found corners and the north one-sixteenth corner established. A 1/2" iron pipe was set in the center of an 8 foot dirt road. A found 3/4" iron pipe bears S. 20° E., 11.7 feet. A true line was run northerly from this corner and stakes set for fencing purposes. From the north one-sixteenth corner a traverse line was run easterly along the south line of Government Lot No. 1. Bearings and distances are based on those appearing and calculated from Hood River County Surveyor's drawing #7574, 1975. At 652.11 feet a 1/2" iron rebar was set at the northeast corner of the west 20 acres of Government Lot 2. The line was continued to the north-south centerline of section and a 5/8" iron rebar set. An old fence corner bears South 52° West 22.4 feet. Offsets to true line for logging purposes are shown on the attached drawing.

Bearings for this survey are based on the west line of the section as shown on County Surveyor drawing No. 7574, 1975. These bearings are based on a solar observation. Corners found or set along with measured bearings, distances and ties are shown on the attached drawing T.E.C. work order #6161, which by reference is made a part hereof.
