In August 1983, Tenneson Engineering Corporation was retained by John F. Cushman to locate pins on a tract of ground previously surveyed by Wall and Tenneson in 1954, located in Sections 27 and 34, Township 3 North, Range 10 East, Willamette Meridian. The intent of the survey was to recover the prior monuments and re-establish additional points on a parcel acquired from the State of Oregon Highway Department.

Prior to undertaking the work, we researched our records and recovered our prior Work Order X-236 which was the survey of the original Cushman parcel. Mr. Cushman provided us with a copy of a map and description believed to have been prepared by George Frey indicating the other parcel.

Work was started by attempting to locate the prior set monuments. After considerable search only two of the points were found on the first leg of the description which was only 32 feet long. This was felt too short a sight to attempt to reconstruct the survey. Therefore, turned the angle from the one found point on the section line in an attempt to recover the section corner 26,728, 33, and 34. Initial search uncovered a $2\frac{1}{2}$ " iron pipe with lead plug and tack in the approximate location this This pipe was known by our partychief to have been set by Mr. corner. Norm Newton several years ago. It did not appear to fit the information shown on the other survey which indicated the corner to be Corps of Engineers brass cap. After additional search and excavation, the original Corps of Engineers brass cap was recovered in good condition. The $2\frac{1}{2}$ " iron pipe found apparently lays on the section line 26 feet to the north. The section line was then pushed through to the north onequarter corner of Section 34, also a Corps of Engineers brass cap, and then the survey traverse laid out pursuant to the original deed descriptions Field Notes John H. and survey plat.

All corners not found were re-monumented with 5/8" iron rods with the additional corners requested by Mr. Cushman set as directed.

Corners found, set, distances and angles measured shown on the attached map of survey for John Cushman, Tenneson Engineering Corporation, Work Order X-236, Revision 1, which by reference is made a portion of these notes.
