Dear George:

Reference is made to survey in Section 23 T 2 N R 9 E. We started at the Southeast section corner and ran a compass line on var. of 20°. At south one quarter corner there is evidence of axe work on 30" pine stump to indicate it is original BT. We set stake at aprox. true corner location in relation to this BT. The calls all fit comming from the east into this corner. We continued west chaining the distance and the calls all fit. At about 14 ft. short of called distance from quarter corner we found the original stone which fits description. We set stake by the stone. We hit about 25 ft. north of the stone for latitude.

We then ran north on same variation and marked line at the road crossing. We hit at 5280 feet north the true commer which fell about 279 feet west and 22 feet south of the end of our mile of random line. We found one original BT to this corner and reset it as described on attached sheet. It falls about 620 feet east of the road at the east end of the dam at the Lower Green Point Reservoir.

## CORNER DESCRIPTION AS SET FOR CORNER TO SECTIONS: 14,15,22,23 T 2 N R 9 E, Hood River County, Oregon

Found the original bearing tree called for a 15" diameter fir N 37° W 30 links. Could clearly see the T 2 N R 9 E and S both on face and overgrowth. bout 75 to 80 rings were counted on overgorwth to assure it is original. We could find no trace of the three other trees. We found an old stake which bears S 45° W 22.30 ft from the true corner location but it was not the original stake. On June 21, 1966 mesureing from the N W bearing tree I set a the corner a 28" x 3/4" galv. iron pipe with a brass cap stamped (22, 23, 14, 15) with 8 "above ground in pile of rocks. It falls on top flat ridge about 620 feet east of th the road at the east end of the Lower Green Point Reservoir. I blazed line out to road and set stake on the road. reference to the corner I drove four railroad spikes with a cross filed on the head of each into the base of the following trees. The distances are from the cross on the spike to the hole in center of corner pipe cap :

8 " diam White Fir - Bears N 10° E distance of 24.70 ft.

14" diam. White Fir - DuerEast33° W distance of 20.21 ft.

12" diam White Fir - Bears S 33° W distance of 24.00 ft.

12" diam. doug. fir - Bears N 82° W distance of 21.10 ft.

No witness to setting corner but witness to finding bearing tree on June 17 was Stanley Thomson.
