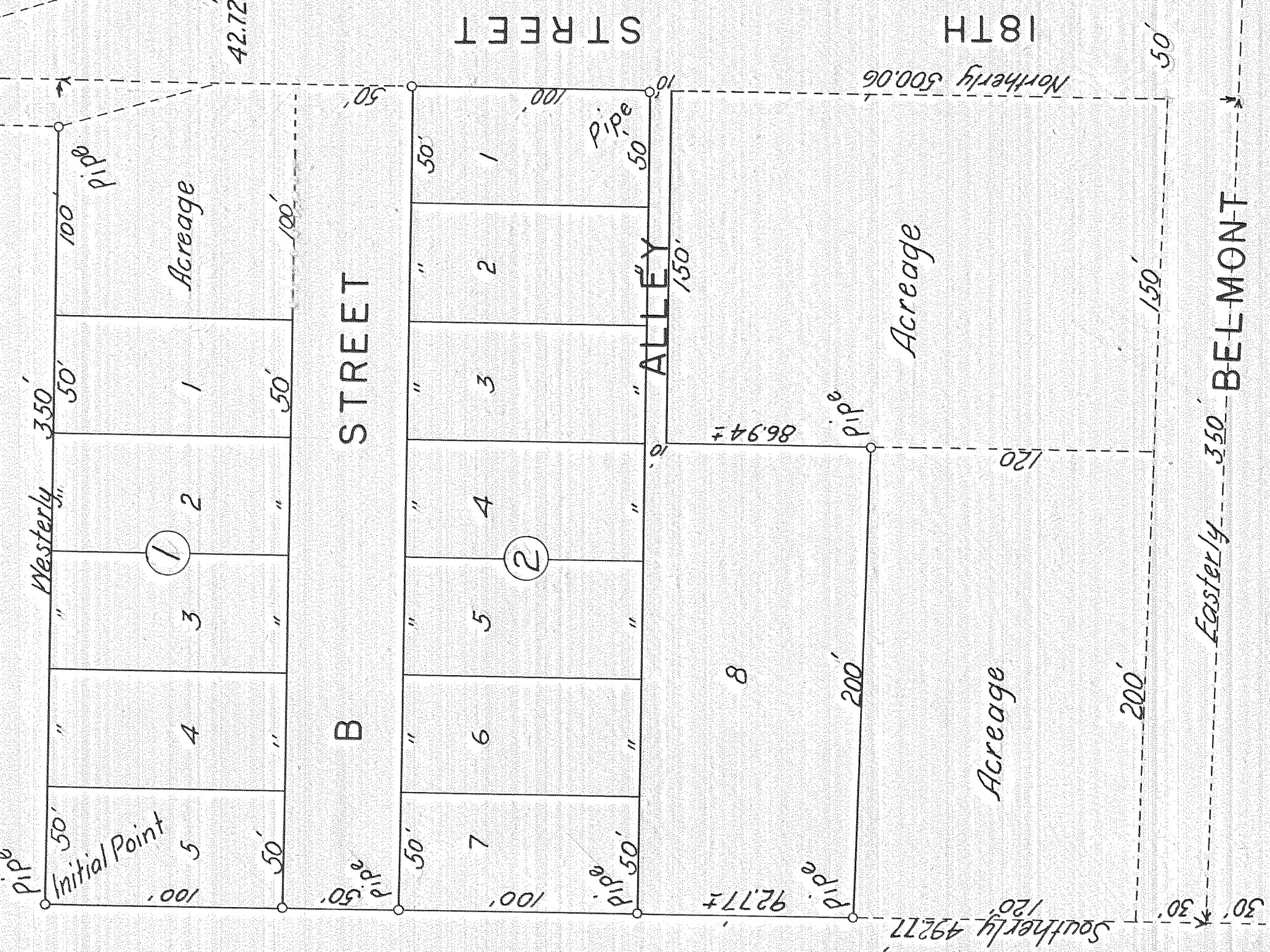




BUSSE'S ADDITION TO HOOD RIVER, OREGON

DESCRIPTION AND DEDICATION

This is to certify that we, Ernst Busse and Waitraud L. Busse, husband and wife, are the owners of the following described tract of land in Section 35, T. 3N., R. 10E., W. 1M. Beginning at a point on an extension westerly of a line drawn between the southeast corner and the southeast re-entrant corner of the William Jenkins Donation Land Claim No. 38, 350 feet westerly from said southeast re-entrant corner and 492.77 feet southerly therefrom on a line 350 feet westerly and parallel with the east line of said Donation Land Claim, which said point is the point of beginning of this description, and running thence Southerly 342.77 feet; thence Easterly, parallel to the center line of the Belmont Road 200 feet; thence North-erly, parallel to the west line of this tract, 86.94 feet; thence Easterly, parallel to the north line of this tract, 150 feet; Thence Northernly, along the east line of said tract, 160 feet; thence West-erly, parallel to the north line of said tract, 100 feet; thence Northernly 100 feet; thence West-erly along the north line of said tract, 250 feet to the point of beginning; that we have subdivided said tract of land into Blocks, Lots, Street and alley as shown on the accom-panying plat; and that said plat is a correct representation of said tract and the subdivis-ion thereof; and that said streets are dedicated to the public forever.

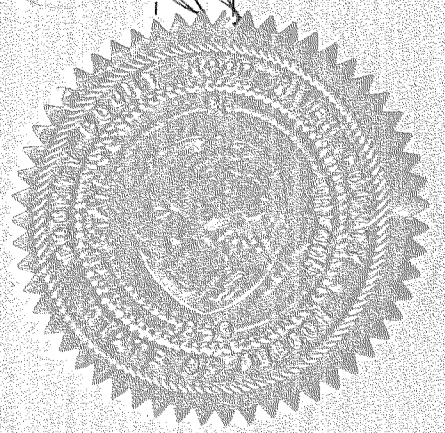
