







Know all men by these presents, That we, John W.Watson, Carrie W.Watson, his wife hereby declare the annexed map to be a true plat of the property owned and laid cut by us as Frwin & Watsons Second Addition to the town of Hood River in the County of Wasco, State of Oregon, and situated T.3, N.R.10 Fast of the Willamette Meridian and being a part of section twenty seven consisting of 35 acres and ten blocks from one to ten inclusive and we hereby dedicate to the use of the public forever the streets as laid out thereon, and known as Pine Ave 60 feet wide in the west side of addition and 30 ft on the west side of addition and 30 ft.
