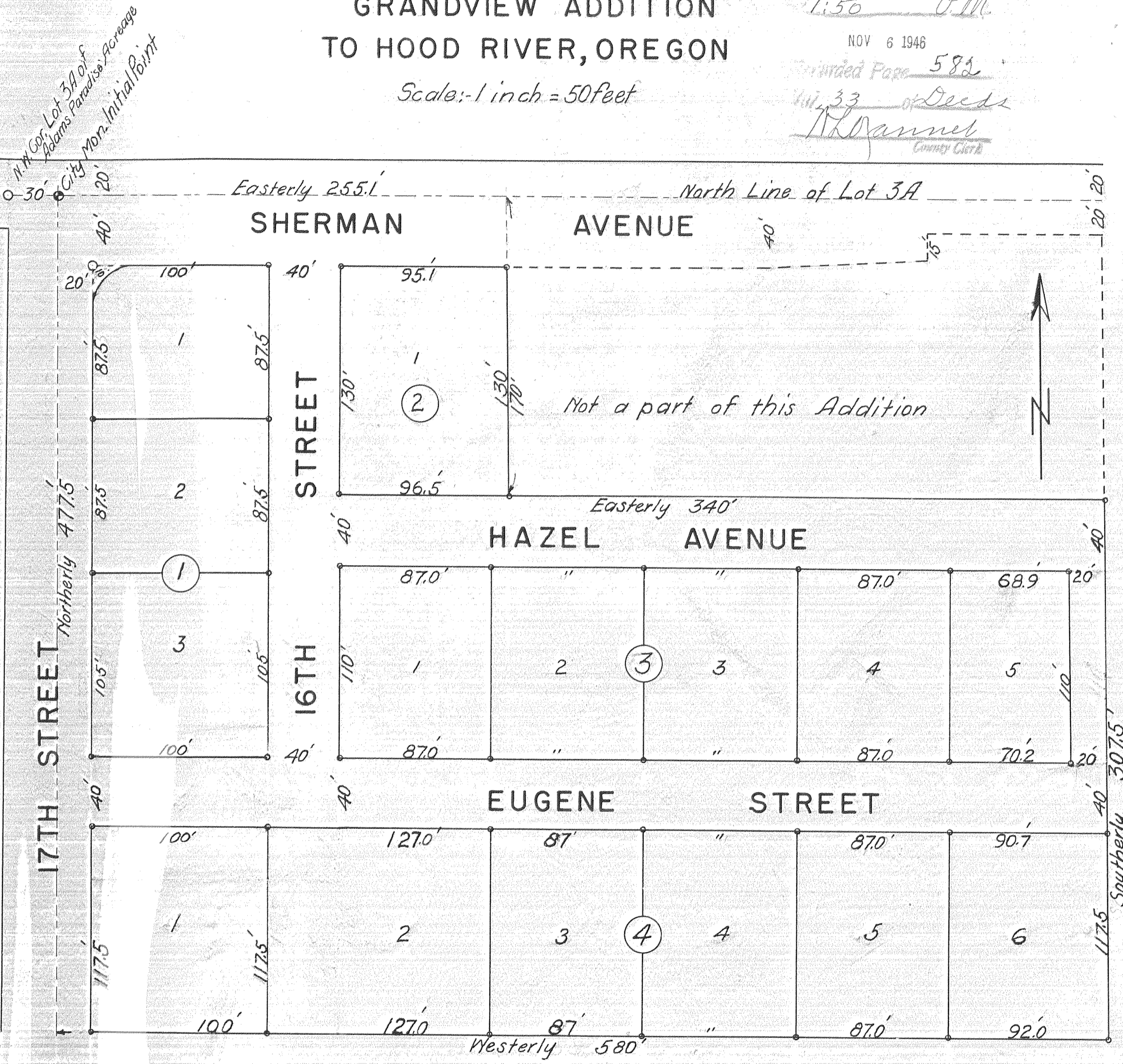


GRANDVIEW ADDITION

DESCRIPTION AND DEDICATION  
This is to certify that we, C.J. Newlin and Alice Newlin, husband and wife, are the owners of the following described tract of land in the N.E. 4 of Section 35, T. 3 N., R. 10 E. W. M. Beginning at a point on the north line of Lot 3A of Adams Paradise Acreage 30 feet east of the N.W. Corner thereof and running thence Easterly along the north line of Lot 3A 255.1 feet; thence Southerly, parallel to the east line of Lot 3A, 170 feet; thence Easterly, parallel to the north line of Lot 3A, 340 feet to the east line of Lot 3A; thence Southerly, along the east line of Lot 3A, 307.5 feet; thence Westerly 600 feet to the center line of 17th Street; thence Northerly, along the center line of 17th Street, 477.5 feet to the point of beginning, that we have subdivided the said tract of land into Blocks, Lots and Streets as shown on the accompanying plat, and that said plat is a correct representation of said tract and the subdivision thereof; and that said streets are dedicated to the public forever.
