

NARRATIVE:
 THE PURPOSE OF THIS SURVEY WAS TO PRODUCE A 26 LOT SUBDIVISION OUT OF TAX LOT 900 OF HOOD RIVER TAX ASSESSORS MAP 3N 10E 35BC. MONUMENTS WERE SET AT ALL LOT CORNERS AND IN THE CENTERLINE OF THE ROADS AS NOTED. THE TOTAL PARCEL CONTAINS 246,070 SQUARE FEET, MORE OR LESS, THAT EXCLUDES THE ACREAGE IN THE 30' RIGHT OF WAY OF MAY STREET.

EASEMENTS OF RECORD:
 PACIFIC POWER HAS A BLANKET EASEMENT FOR A RIGHT OF WAY RECORDED IN DEED BOOK 38 AT PAGE 427, HOOD RIVER COUNTY DEED RECORDS.

PACIFICORP HAS A 10' BY 500' EASEMENT FOR A RIGHT OF WAY ALONG THE EAST SIDE OF THE SUBDIVISION RECORDED IN MICROFILM NUMBER 20044046, HOOD RIVER COUNTY DEED RECORDS. THE CURRENT EASEMENT IS NOW BEING VACATED BY PACIFICORP. THE NEW UNDERGROUND UTILITIES ARE NOW RELOCATED ALONG THE EAST SIDE OF THE SUBDIVISION IN THE NEW EASEMENT LOCATION.

NOTES:
 THE NEW EASEMENTS SHOWN ON THE PLAT HAVE THE PURPOSE INDICATED AT EACH LOCATION. REFER TO THE TYPICAL EASEMENT SKETCH FOR PURPOSE AND DIMENSIONS.
 THE PUBLIC DETENTION POND IS DESIGNED TO GATHER THE STORM SEWER WATER FROM THE LAND CONTAINED WITHIN THE SUBDIVISION.

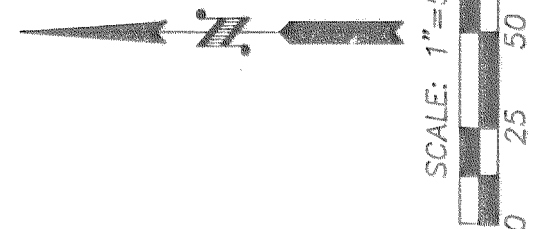

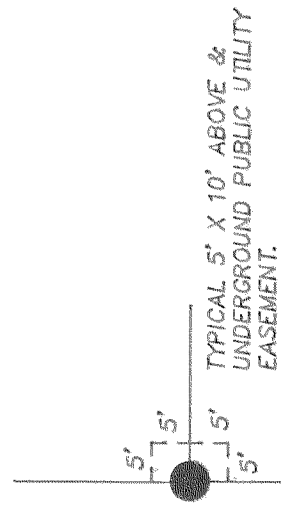
