

AN ORDERANCE determining in favor of the vacation of a portion of Sixth Street, 65 % 9.5 feet, adjoining the North line of Columbia Street within the City of Hood Niver, Oregon, and directing that a copy hereof be filed with the County Clerk of Rood River County, Oregon.

WHEREAS, the Compa Council of the City of Hood River, pursuant to Laws provided, initiated proceedings for the vacation of a portion of Sixth Street, hereinafter; nore rarticularly described; and
