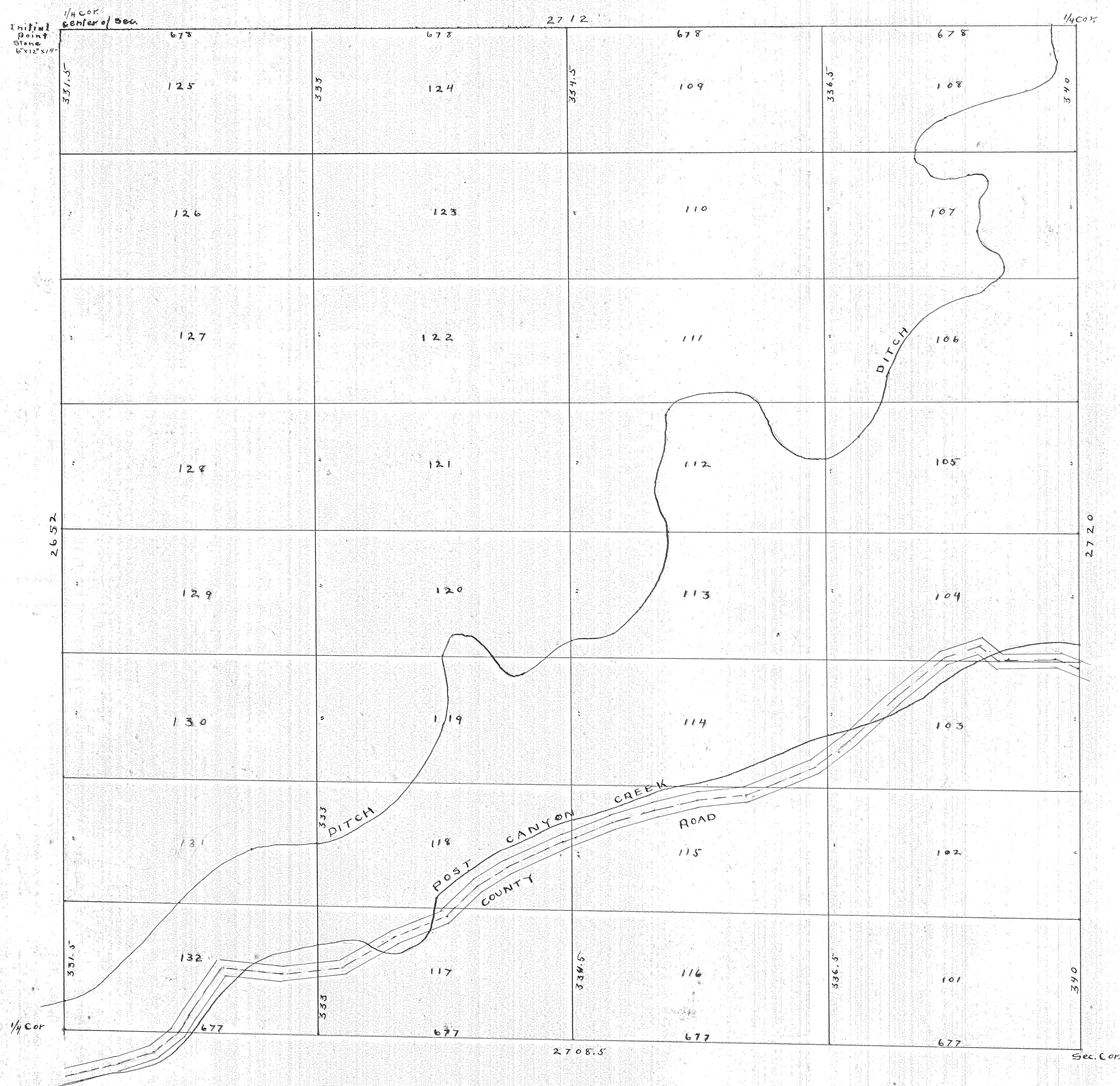


PLAT OF THE PROPERTY OF THE HOOD RIVER LAND CO.

SURVEYOR'S CERTIFICATE.

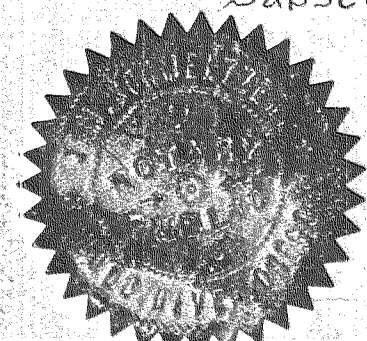
