



KNOW ALL MEN BY THESE PRESENTS, That THE TITLE GUARANTEE AND TRUST COMPANY, a corporation under the laws of Oregon, S. A. KNAPP and C. M. KNAPP, his wife, of Hood River, Oregon, J. POLIVKA and Ang POLIVKA his wife, of Portland, Oregon, and JOSEPH F. BATCHELDER and R. R. ERWIN, as Trustees, have caused to be resurveyed the townsite of Idlewilde Addition to Hood River, and a strip of land adjoining thereto on the north, in the County of Wasco and State of Oregon, and have caused to be set stone monuments along the east line thereof and one 4,5 feet south of the northwest corner thereof, and one at the southwest corner thereof, and iron pipes to be set at the corners of each of the blocks thereof, which re-survey is in accordance with the plat attached hereto and made a part hereof; That the initial point of such re-survey is at a stone monument set in the west line of the Nathaniel Coe Donation Land Claim No. 37, Township Three (3) North of Range Ten (10) East of the Willamette Meridian, 823 feet southerly from a stone monument at the northwest corner of said claim.

And the parties hereinabove named do hereby declare the annexed plat to be the Amended plat of Idlewilde Addition to Hood River, and a correct representation of the land known as such, showing the streets, avenues, roads, lots and blocks thereof, the original survey and plat of said Idlewilde Addition to Hood River having been imperfect and erroneous; And do declare that the land represented by said annexed plat shall be henceforth known as Idlewilde Addition to Hood River. And do hereby dedicate to the public forever for use as highways and streets in lieu of the highways and streets shown by the original plat of said land, River Street, Columbia Street, Durham Street, Wasco Street, and Military Avenue, and those parts of Adams Street and Hood Street which lie between River Street and a line 200 feet north of and parallel with Wasco Street as shown by said plat. IN WITNESS WHEREOF, said The Title Guarantee and Trust Company in accordance with a resolution of its Board of Directors duly adopted has caused these presents to be executed in its name and under its corporate seal by its Secretary, and the other parties hereto have set their hands and seal this fourth day of May, 1903.
