



LEGAL DESCRIPTION OF THE SUBDIVISION:

All of Lot 22, ADAMS PARADISE ACREAGE, in the County of Hood River and State of Oregon EXCEPTING THEREFROM the following described tract of land: Beginning at the Southeast corner of said Lot 22, ADAMS PARADISE ACREAGE; thence North along the East boundary line of said Lot, 320 feet; thence West 200 feet; thence South 60 feet; thence West 120 feet; thence South 20 feet; thence West 123.52 feet to the West boundary line of said Lot 22; thence South along the West boundary line of said Lot, 240 feet to the Southwest corner of said Lot 22; thence East along the South boundary line of said Lot, 443.52 feet to the place of beginning.

ALSO EXCEPTING THEREFROM, a parcel of land located in the Southeast quarter of the Southwest quarter of Section 26, Township 3 North, Range 10 East of the Willamette Meridian in the County of Hood River and State of Oregon, being more particularly described as follows: Commencing at the Northeast corner of Lot 22, ADAMS PARADISE ACREAGE; thence South 00°37'22" West along the East line of said Lot 22 a distance of 478.43 feet to a point 320 feet from the Southeast corner of said Lot 22; thence North 89°10'01" West parallel with the South line of said Lot 22 a distance of 200.00 feet; thence North 1°24'19" East a distance of 303.42 feet to the point of beginning of the following described parcel: Continuing North 1°24'19" East a distance of 175.27 feet to the North line of the William Jenkins Donation Land Claim No. 38; thence North 14°15'58" East a distance of 157.54 feet to the Southerly right of way of the Columbia River Highway (Cascade Avenue); thence North 75°08'59" West along said right of way a distance of 75.00 feet; thence South 14°15'58" West a distance of 176.12 feet to the said North line of said Donation Land Claim No. 38; thence North 89°05'46" West along said Claim line a distance of 172.97 feet to the Northwest corner of said Lot 22; thence South 00°25'55" West along the West line of said Lot 22 a distance of 175.27 feet; thence South 89°05'46" East parallel to the North line of said Claim line and Lot 22 a distance of 247.08 feet to the point of beginning.

Thence North 89°05'46" West along the North line of said Lot 22 a distance of 80.55 feet (78.13 feet by previous deed call) to the Southeast corner Parcel 2 of that tract of land conveyed to Jack Rowe Miller et ux., by deed recorded June 22, 1962 in Book 71 on page 151 of Hood River County Deed Records and the point of beginning of the following described tract. Thence continuing North 89°05'46" West along said North line a distance of 112.91 feet; thence North 14°15'58" East a distance of 157.54 feet to the Southerly right of way of the Columbia River Highway (Cascade Avenue); thence South 75°08'59" East along said right of way a distance of 78.13 feet to the Northeast corner of Parcel 2 of said Miller tract; thence South 0°36'56" West along the East line of said Miller tract a distance of 134.44 feet to the point of beginning.
