

I, L.A. Henderson being first duly sworn, depose and say, that I am a competent Surveyor, and that I have correctly surveyed the parcel of Land shown on the within Plot, being Lot 25 Adams Paradise Acreage as described in the above dedication, and that I have placed a Stone marked 'X' on top, 4x6x12", top 6" below ground, in Adams Street, dist East 541.83' from the N. Sec.
