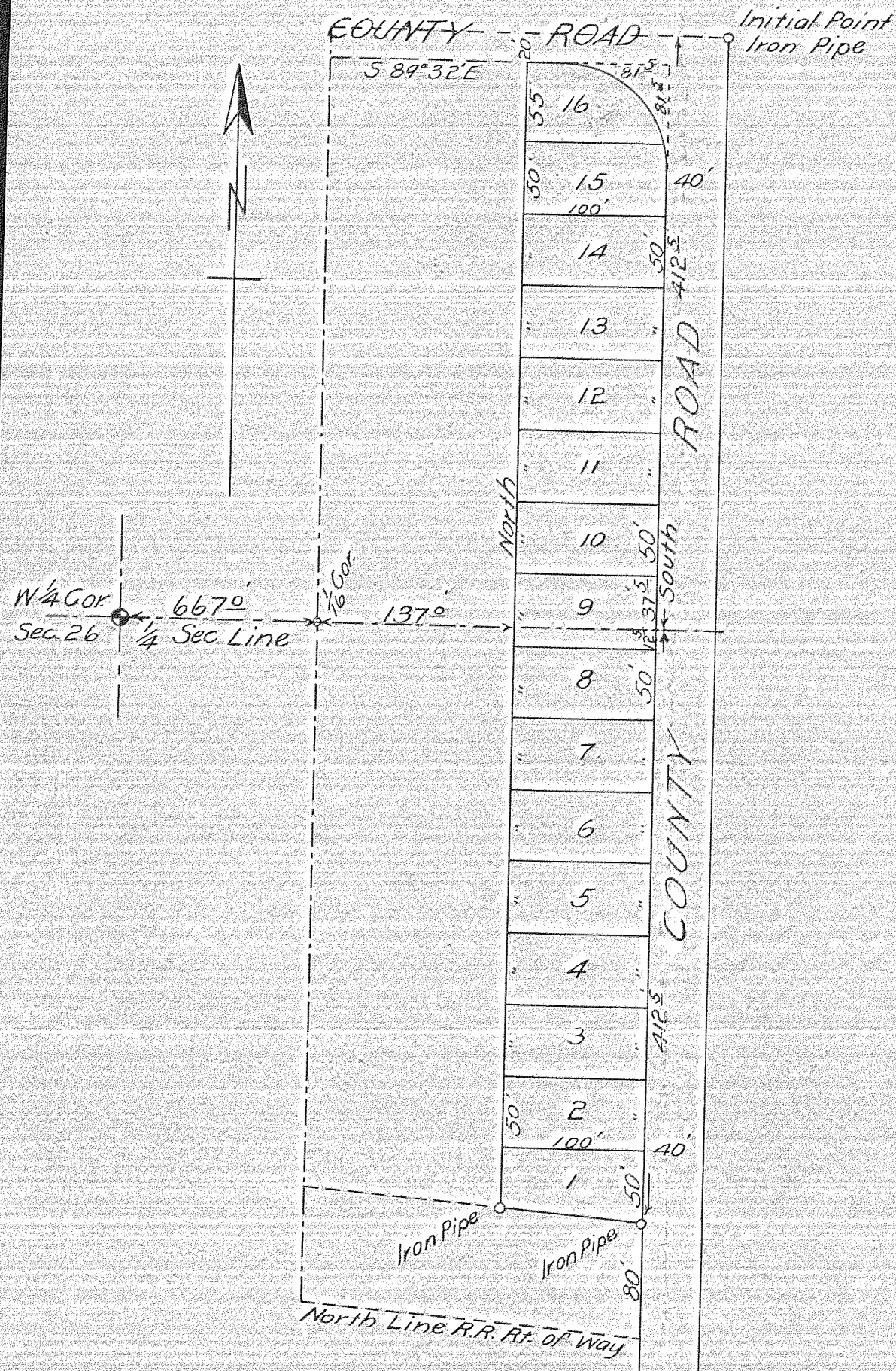


PLAT OF FIRST ADDITION TO ODELL OREGON

This is to certify that I, Charles T. Early, trustee, am the owner of the following described tract of land to-wit :- beginning at a point on the $\frac{1}{4}$ Section Line 804 ft. East of the W $\frac{1}{4}$ Cor. of Section 26, T.2 N. R. 10 E. W. M. and running thence North 392⁵ feet; thence S. 89°32'E. 24⁵ feet; thence along a curve to the right whose radius is 82³ feet a distance of 118⁴ ft.; thence South 730³ feet to the north line of the Mount Hood Railroad Right of Way; thence ^{westward} along the north line of the Right of Way; thence North to the point of beginning, containing 1.82 Acres; that I have subdivided said tract of land into lots as shown on the accompanying plat, and that said plat is a correct representation of said tract and the subdivision thereof.

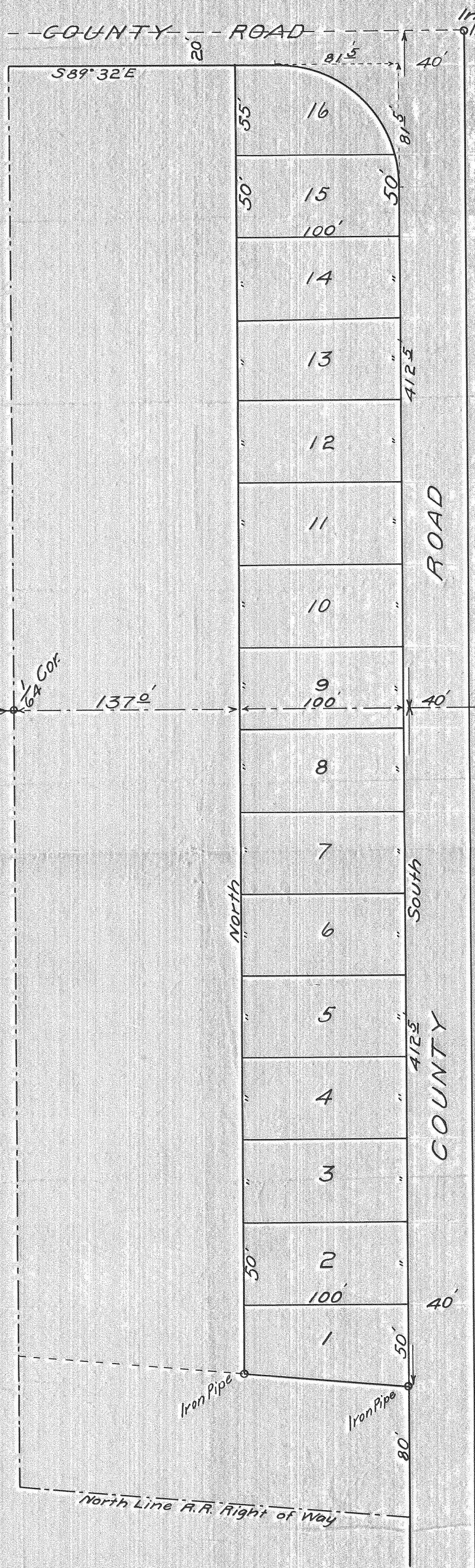
