NARRATIVE:

THE PURPOSE OF THIS PLAT IS TO CREATE A PLANNED UNIT DEVELOPMENT SUBDIVISION OF TAX LOT 3600, ASSESSORS MAP 2N-11E-06. PHASE 1 OF THE DEVELOPMENT WILL CONTAIN 5 LOTS OF 2 ACRES, AND 2 OPEN SPACE AREAS. PHASE 2 OF THE DEVELOPMENT IS RESERVED FOR THE FUTURE. MONUMENTATION WAS FOUND AT THE OUTBOUNDS OF TAX LOT 3600, EXCEPT THE NORTHEAST CORNER OF SOUTHEAST CORNER OF SECTION 6. I CALCULATED THIS POSITION BASED ON HOOD RIVER COUNTY SURVEY #94133. THIS CORNER IS LOCATED 1217.02 FEET NORTH OF THE A 1/2" IRON ROD L.S. 1028 MONUMENTING THE CENTERLINE OF THE BONNEVILLE—THE DALLES TRANSMISSION LINE. WE HELD OTHER MONUMENTS WHICH WERE SET ON C.S. 94133. THE LEGAL DESCRIPTION REFERENCES MORE OR LESS CALLS AS SHOWN ON SAID SURVEY #0619 IT READS AS FOLLOWS, "851.05 FEET TO THE LOWER BANK, BEING THE WESTERLY BANK, OF THE EAST FORK IRRIGATION DISTRICT DITCH; THENCE FOLLOWING SAID DITCH ECT..." IN THE FIELD WE HAD A CLEAR BANK WHICH WE TIED DURING THE BEGINNING OF THIS PROJECT. THE BEARING AND DISTANCES MORE OR LESS FOLLOW SAID SURVEY #0619, BUT NOT EXACTLY. WE HELD THE WESTERN BANK AS A NATURAL MONUMENT TO THE EAST LINE OF DEVELOPMENT.
