I, KEVIN DOWD, CERTIFY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS THE LAND REPRESENTED ON THE ANNEXED MAP OF PRICE ADDITION, SAID LAND BEING DESCRIBED AS FOLLOWS:

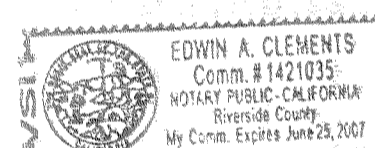
