DESCRIPTION AND DEDICATION

This is to certify that we, J.M. Puddy and Mildred V. Puddy, husband and wife, are the owners of the following described tract of land, to-wit: Beginning at the northeast corner of the north-west quarter of Section 35, Township 3 North, Range 10 East of the Willamette Meridian, thence west along the north line of said Section 35, 9.045 chains to the northeast corner of a ten-acre tract owned by A.C. Lender and wife; thence south along the east line of said Lender's 10 acres 9.875 chains to the Northwest corner of a certain 10 acres owned by Leon M. 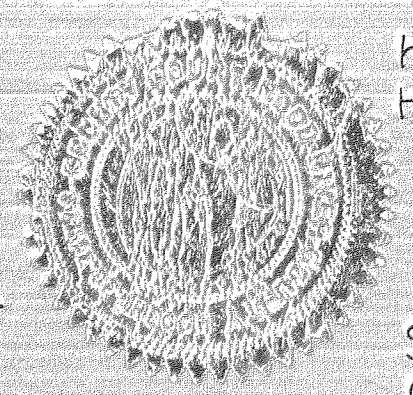

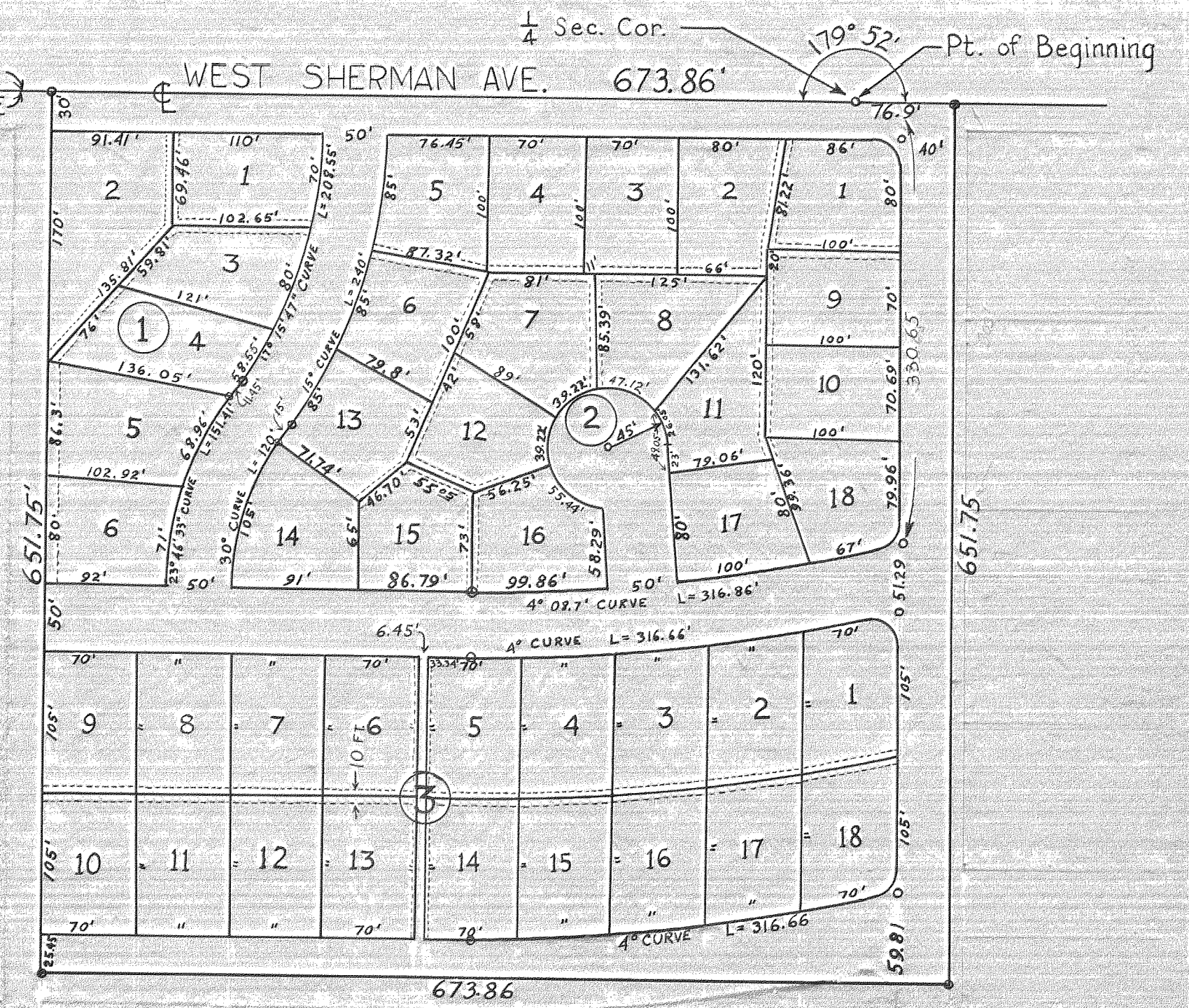
