



AN AESTHETIC AND WILDLIFE CONSERVATION EASEMENT CREATED BY THIS PLAT. THE STONEGATE HOMEOWNERS ASSOCIATION RETAINS AN EASEMENT TO PLANT AND MAINTAIN A HEDGE AROUND THE PERIMETER OF STONEGATE DEVELOPMENT. THE HEDGE IS INTENDED TO PROVIDE AN ATTRACTIVE GREEN AND FLOWERING PRIVACY SCREEN FOR HOMEOWNERS AND FOOD AND COVER FOR WILDLIFE. THE HEDGE SHALL HAVE A MINIMUM HEIGHT OF 7 FEET AT PLANT MATURITY. THE ASSOCIATION MAY PERFORM SUCH MAINTENANCE AS WATERING, TRIMMING, FERTILIZING AND ENHANCING THE HEDGE BY BOTH ADDITIONS AND REMOVALS OF PLANTS. A MINIMUM OF 80% OF THE HEDGE SHALL BE COMPOSED OF PLANTS NATIVE TO THE PACIFIC NORTHWEST. HOMEOWNERS ARE, HOWEVER, ENCOURAGED TO DO THEIR OWN MAINTENANCE OF THE HEDGE ON THEIR PROPERTY AFTER FIRST OBTAINING APPROVAL OF THE ASSOCIATION.

SUBJECT TO A 15 FOOT WIDE IRRIGATION LINE EASEMENT CREATED BY FEE NO. 820389. AFFECTS THAT PORTION OF STONEGATE EAST PHASE THREE THAT LIES WITHIN THE WEST 15 FEET OF THE EAST 543 FEET OF THE NORTHWEST 1/4 OF SECTION 34. IT SHOULD BE NOTED THAT THE EXISTING AS BUILT IRRIGATION LINE DOES NOT FALL WITHIN THE ABOVE DESCRIBED EASEMENT LIMITS.
