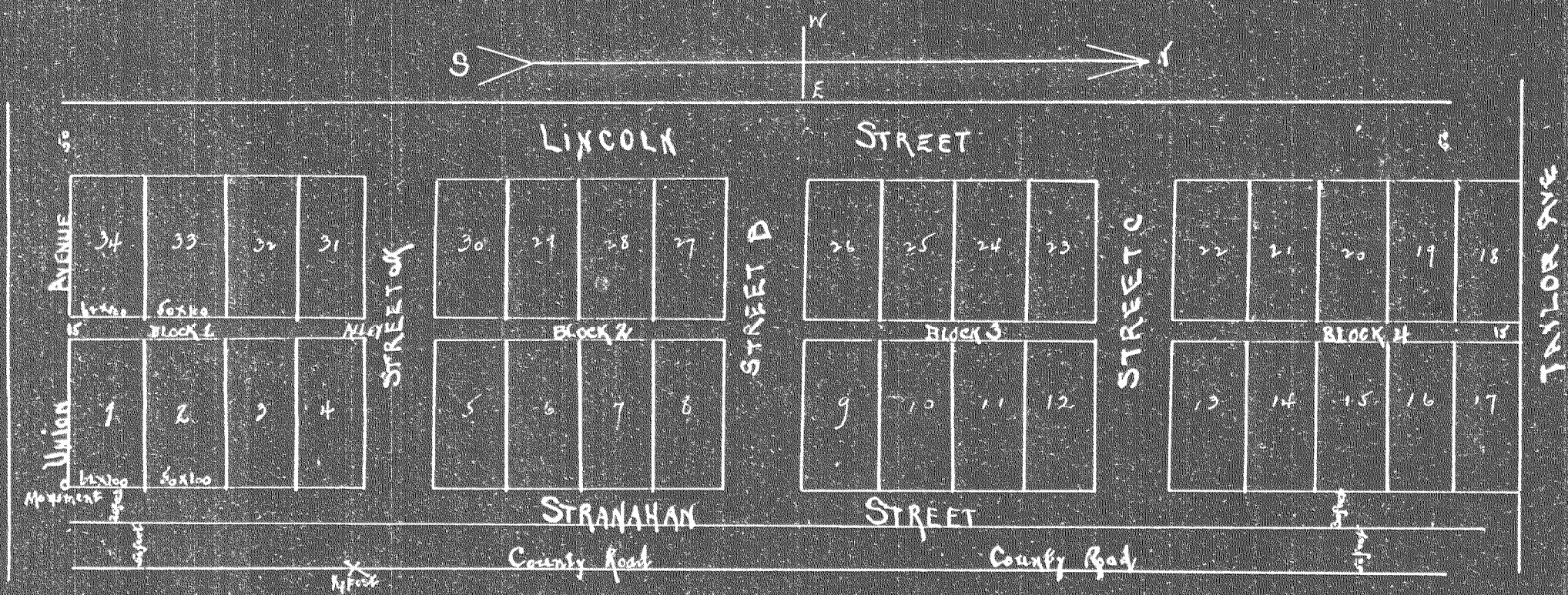


MOUNTAIN VIEW.

DEDICATION.

We, the undersigned proprietors of the annexed Addition to Hood River, do hereby certify, that the accompanying plat is a correct presentation of the same; that the same comprises a tract of land beginning at a point and place 195 feet south and 20 feet west of the quarter post between Sections No. 35 and 36 township No. 3 North range No. 10 East W.M. Thence North (1012) feet, intersecting a road, running from most South East Angle of the Wm. Benson D.M.C. No. 38, East to section line between Secs. 35 & 36; thence west 265 feet; Thence South (1012) feet; thence east 265 feet to place of beginning, said tract of land bounded on the North, South and East by roads, 2 of them being roads of record, that I have caused to be fixed at the South East corner of Block 1 and North West corner of Block 4 as shown on said plat, permanent stone corners sunken and cemented; from which to make future surveys. 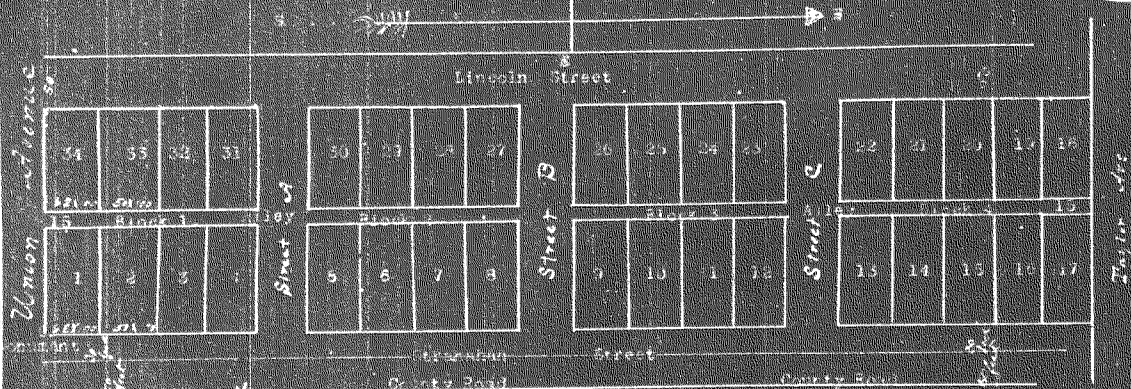

We the undersigned proprietors of the annexed Addition to Hood River, do hereby certify that the accompanying plat is a correct presentation of the same, that the same comprises a tract of land beginning at a point and place 195 feet south and 50 feet west of the quarter post between Sections No 35 and 36 Township No 3 North Range No 10 East W.M.; thence North (1012) feet, intersecting a road, running from most South East Corner of the W. Benson D.M. No 58, East to section line between Secs 36&35, thence east 50 feet; thence South (1012) feet; thence East 205 feet to place of beginning, said tract of land bounded, on the North, South and East by roads; 2 of them being roads of record; that I have caused to be filed at the South East corner of Block 1 and North West corner of Block 4 as shown on said plat permanent stone corners marked and centered, from which to make future surveys, and we do hereby donate to the public, for the uses and purposes named on this plat all streets, avenues, and Alleys shown on said plat.
