I, ERIK M. CARLSON, REGISTERED LAND SURVEYOR FOR THE STATE OF OREGON, BEING FIRST DULY SWORN, DEPOSED AND SAY THAT I HAVE CORRECTLY SURVEYED THE PROPERTY DESCRIBED IN THE LEGAL DESCRIPTION AND MARKED WITH LEGAL MONUMENTS THE LAND REPRESENTED ON THE PLAT OF "VALVERDE VISTAS" SUBDIVISION HOOD RIVER COUNTY, STATE OF OREGON,

A TRACT OF LAND DESCRIBED ON DEED TO ERIC ROSS POLLARD AND ERIN VALVERDE POLLARD ON INST#2019-02116, RECORDED ON JULY 12, 2019, HOOD RIVER COUNTY RECORDS. TRACT IS LOCATED IN A PORTION OF THE NORTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 27, TOWNSHIP 1 NORTH, RANGE 10 EAST, WILLAMETTE MERIDIAN IN THE COUNTY OF HOOD RIVER AND STATE OF OREGON, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF GOVERNMENT LOT 12 OF SECTION 27, TOWNSHIP 1 NORTH, RANGE 10 EAST OF THE WILLAMETTE MERIDIAN, IN THE COUNTY OF HOOD RIVER AND STATE OF OREGON, THENCE NORTH 01 20'34" EAST, ALONG THE WEST LINE OF SAID GOVERNMENT LOT 12, A DISTANCE OF 189.75 FEET; THENCE SOUTH 85'07'51" EAST, PARALLEL TO THE SOUTH LINE OF GOVERNMENT LOT 12, A DISTANCE OF 443.00 FEET TO THE TRUE POINT OF BEGINNING OF THE HEREIN DESCRIBED PARCEL OF LAND; THENCE SOUTH 01'02'09" WEST A DISTANCE OF 139.72 FEET TO A POINT 50.00 FEET NORTH OF THE SOUTH LINE OF SAID GOVERNMENT LOT 12; THENCE NORTH 85'07'51" WEST, PARALLEL TO THE SOUTH LINE OF SAID GOVERNMENT LOT 12 A DISTANCE OF 362.05 FEET TO THE EAST LINE OF HIGHWAY 35 AS CONVEYED TO THE STATE OF OREGON, ON INST#920540 IN DEED RECORDS HOOD RIVER COUNTY; THENCE NORTH 00'50'36" EAST, ALONG THE EAST LINE OF SAID EAST LINE A DISTANCE OF 90.64 FEET TO A 5/8" IRON ROD WITH ODOT CAP; THENCE NORTH 00°50'36" EAST A DISTANCE OF 49.11 FEET TO A POINT 189.75 FEET NORTHERLY OF THE SOUTH LINE OF SAID GOVERNMENT LOT 12; THENCE SOUTH 85'07'51" EAST, PARALLEL TO THE SOUTH LINE OF SAID GOVERNMENT LOT 12 A DISTANCE OF 362.52 FEET TO THE TRUE POINT OF BEGINNING

INITIAL POINT OF THIS SUBDIVISION IS A 5/8" IRON ROD, L.S.1028 FOUND AT THE SOUTHEAST CORNER OF THE SUBJECT TRACT, LOCATED AT THE INTERSECTION OF THE NORTHERN RIGHT OF WAY OF CUNNINGHAM ROAD, BEING 50 FOOT NORTH OF THE SOUTH LINE OF GOVERNMENT LOT 12 AND 443.75 FEET EAST OF THE WEST SECTION LINE AS MEASURED ON A PARALLEL LINE TO THE SOUTH LINE

OF GOVERNMENT LOT 12. Larlson ERIK M. CARLSON PLS 72306

THE PURPOSE OF THIS PLAT IS TO CREATE A FIVE LOT SUBDIVISION ON TAX LOT 700, ASSESSORS MAP 1N-10E-27CB, DESCRIBED ON LAND DEVELOPMENT REPORT NO 19-0112ED. THE DEED ELEMENTS HELD TO DETERMINE THE BOUNDARY IS THE LOCATION OF THE SOUTH LINE AND WEST LINE OF GOVERNMENT LOT 12, THE WEST LINE OF GOVERNMENT LOT 12 IS THE SAME AS THE WEST LINE OF SECTION 27. WE TIED BRASS CAPS MONUMENTING THE NORTHWEST AND SOUTHWEST CORNERS OF SECTION 27, THE WEST QUARTER CORNER WAS NOT FOUND. WE CALCULATED THE WEST QUARTER CORNER BASED ON THE RESOLUTION FROM DOWD, L.S.2393 ON C.S.2016—023. THIS RESOLUTION IS BASED ON HOLDING THE RECORD BEARINGS TO PLACE THE QUARTER CORNER. THIS RESOLUTION SEEMS TO BE THE MOST REPEATABLE FROM SURVEYS IN THE AREA. THE LOCATION OF THE SOUTH LINE OF GOVERNMENT LOT 12 WAS HELD BY HOLDING COMMON MONUMENTS USED ON C.S.2016—023 AND C.S.87057. WE MEASURED A DISTANCE TO THE NORTH FROM THE BRASS CAP AT THE SOUTHWEST SECTION CORNER. THE DISTANCE MEASURED OF THE DOWN MEASUREMENT AND 0.73 FEET SHORT OF THE CRON'S MEASUREMENT, I AM CHOOSING TO HOLD A 1/2" IRON ROD (C.S.87057) FOUND AT THE NORTH LINE AND WEST END OF A 50 FOOT ACCESS AND UTILITY EASEMENT (CUNNINGHAM DRIVE, INST#872587), WHICH IS DESCRIBED AS 50 FOOT AND PARALLEL TO THE SOUTH LINE OF GOVERNMENT LOT 12. THE REASON FOR THIS DECISION IS THE PROXIMITY TO SAID SOUTH LINE OF GOVERNMENT LOT 12 AND BEING A LONG STANDING MONUMENT AND REPRESENTED ON INST#872587. THE DESCRIPTION CALLS NORTH ALONG PROXIMITY TO SAID SOUTH LINE OF GOVERNMENT LOT 12 AND BEING A LUNG STANDING MONOMENT AND REPRESENTED ON INST#872007. THE DESCRIPTION CALLS NORTH ALONG SAID WEST LINE A DISTANCE OF 187.75 WE RECOVERED A 5/8" IRON ROD (C.S.80025) NEAR THE RIGHT OF WAY AT THE APPROXIMATE DISTANCE FROM THE SOUTH PER DEED. THIS MONUMENT WAS NOT HELD AS IT DOES NOT REPRESENT THE TRUE EAST RIGHT OF WAY OF HWY 35. THE DESCRIPTION CALLS EAST AND PARALLEL TO SAID SOUTH LINE A DISTANCE OF 443 FEET TO THE POINT OF BEGINNING OF THIS DESCRIPTION, THIS POINT WAS ORIGINALLY SET ON C.S.87057, BUT WAS MISSING, WE DECIDED TO REPLACE THIS POSITION BASED ON THE DEED DISTANCE OF 443 FEET FROM THE SECTION LINE AND THE DISTANCE CALL TO THE SOUTH OF 139.72 FEET TO A POINT 50 FOOT NORTH OF THE SOUTH LINE OF SAID GOVERNMENT LOT 12, WHICH WAS MONUMENTED BY CRON ON C.S.872587. THE DEED CONTINUES TO THE WEST AND PARALLEL TO THE SOUTH LINE OF GOVERNMENT LOT 12, BEING THE NORTH LINE OF SAID SOLVEYED BY DEED, BK 64, PAGE 741, THE SOUTH LINE OF SAID SOLVEYED BY DEED, BK 64, PAGE 741, THE SOLVEY AND THE SOUTH LINE OF SAID CONCENHENT LOT 15. THENCE NORTH 00°48'23" EAST ALONG SAID RIGHT OF WAY A DISTANCE OF 139.76 TO A POINT MEASURING 189.75 NORTH FROM THE SOUTH LINE OF SAID GOVERNMENT LOT 12. THE DEED EXCEPTS THE PORTION CONVEYED TO THE STATE OF OREGON BY DEED INST.920540 AS MONUMENTED BY ODOT RIGHT OF WAY MONUMENTS ALONG THE TANGENT OF THE HIGHWAY AS SHOWN ON C.S.#2000-071, WHICH INCLUDES A BRASS CAP MONUMENTING THE CENTERLINE OF SAID HIGHWAY. I USED THESE MONUMENT TO DETERMINE THE STATIONING ON BOTH ODOT MAPS 88-17-19 AND 98-2-11 AS THEY ARE DESCRIBED WITH DIFFERENT STATIONING FORMATS. WE SET MONUMENTS ON THE RIGHT OF WAY, HOLDING 5/8" IRON RODS FROM THE ODOT ALIGNMENT CREATING A TANGENT EASTERN RIGHT OF WAY, 50 FOOT EAST OF MONUMENTED LINE PER 9B-2-11 (INST#920540).

THE BASIS OF BEARING IS OREGON NORTH STATE PLANE COORDINATE SYSTEM, USING BRASS CAPS RECOVERED ON THE WEST QUARTER LINE.
