Field Notes to Townsite of Waucoma Var. 21° E.

Beginning at the 1/4 sec. corner common to Sections 25 and 36 Tp. 3, N.R. 10 E.W.M. thence S. 87° 03' W. on Sec. Line 15.52 ch. to division line running North and South between the land claims of H.W. and H.C. Coe being the Donation Land Claim of H. Coe No. — thereon said division line 4.22 ch. where I set an iron rod 2 feet long as the point of beginning to Town of Waucoma from which I run N 200 feet, thence S. 87° 03' W. 700 ft, thence S 200 feet thence N. 87° 03' E. 700 ft. to place of beginning, containing 28 lots 50x100 feet, each, being block #1.

Block #2 commencing at the N.E. corner of Bl. #1, thence S. 87° 03' W. 20 ft thence N. 60 ft for Oak St. to S.E. cor. Blk. #2; thence N. 200 ft, thence S. 87° 03' W. 200 ft; thence S. 200 ft thence N. 87° 03' E. 200 ft to place of beginning for Blk #2, containing 12 lots 50 X 100 ft each.

Block #3, commencing at N.E. cor. Blk #2; thence N. 60 ft for River St. to S.E. cor. Blk #3 thence S. 200 ft (same description as Blk #2).

Block #4, commencing at the N.E. cor. Blk #3 thence N. 60 ft for Oak St. to cor. Blk #4, thence N. 200 ft thence S. 87° 03' W. 600 ft; thence S. 200 ft; thence N. 87° 03' E. 600 ft to place of beginning for Blk #4 containing 26 lots 50 X 100 ft each excepting lots 7 and 20 which 50 X 100 ft each.

Block #5, commencing at the S.W. cor. Block #3 thence S. 87° 03' W. 60 ft. for 2nd St; thence N. same description as block #3, containing 12 lots 50 X 100 ft. each.

Block #6, commencing at S.W. cor. Block #2 thence S. 87° 03' W. 60 ft for 2nd St. to S.E. cor of Blk #6; thence N. (same description as Blk #2) containing 12 lots 50 X 100 ft each.

Section A, commencing at the S.E. cor. Block #3; thence S. 80 ft for Waucoma Avenue thence S. 150 ft; thence S. 87° 03' W. 700 ft; thence S. 150 ft; thence N. 87° 03' E. 700 ft to place of beginning, containing 7 lots 100 X 150 feet e.e.

Section B, commencing at the S.E. cor. Section A thence S. 60 ft for Pine St; thence S. same description Section A containing 7 lots 100 X 150 feet each.
