Field Notes of the Survey of Winans' Addition to Hood River, Oregon,

Beginning at the intersection of East Line of Donation Claim No. 37 and Section line common to Secs. 25 and 36 T. 3 N. Range 10 E. W. 1. Thence North 89°21' East on said Sec. line 975 ft. Thence South 686 ft, thence west 975 ft, thence North on East line of Donation Claim No. 37, 675 ft, to place of beginning. From place of beginning already described I now run South 25 ft Thence East across street 25 ft to N.W. Cor. of Block 1; thence East 200 ft. to N.E. Cor. of Block 1, thence East across street 50 ft to N.W. Cor. of Block 2, thence East 200 ft to N.E. Cor. of Block 2, thence East across street 50 ft to N.W. Cor. of Block 3, thence East 200 ft to N.E. Cor. of Block 3; thence East across street 50 ft to N.W. Cor. of Block 4, thence East 200 ft to N.E. Cor. of Block 4; thence South 300 ft to S.E. Cor. of Block 4 and to street, thence West 200 ft to S.W. Cor. of Block 4; thence West 50 ft across street to S.E. Cor. of Block 3, thence West 200 ft to S.W. Cor. of Block 3, thence West across street 50 ft to S.E. Cor. of Block 2, thence West 200 ft to S.W. Cor. of Block 2; thence West across street 50 ft to S.E. Cor. of Block 1, thence West 200 ft to S.W. Cor. of Block 1; thence North 300 ft to N.W. Cor. of Block 1; from the S.W. Cor. of Block 1, I now run South across street 50 ft to N.W. Cor. of Block 8, thence East 200 ft to N.E. Cor. of Block 8; thence east across street 50 ft to N.W. Cor. of Block 7, thence east 200 ft to N.E. Cor. of Block 7; thence east across street 50 ft to N.W. Cor. of Block 6; thence east 200 ft to N.E. Cor. of Block 6, thence east across street 50 ft to N.W. Cor. of Block 5; thence east 200 ft to N.E. Cor. of Block 5 and to east boundary, thence south 300 ft to S.E. Cor. of Block 5 (thence west 200 ft to S.W. Cor. of Block 5) thence West across street 50 ft to S.E. Cor. of Block 6, thence West 200 ft to S.W. Cor. of Block 6; thence West across street 50 ft to S.E. Cor. of Block 7; Thence west 200 ft to S.W. Cor. of Block 7; thence West across street 50 ft to S.E. Cor. of Block 8; thence west 200 ft to S.W. Cor. of Block 8; thence North 300 ft to N.W. Cor. of Block 8.

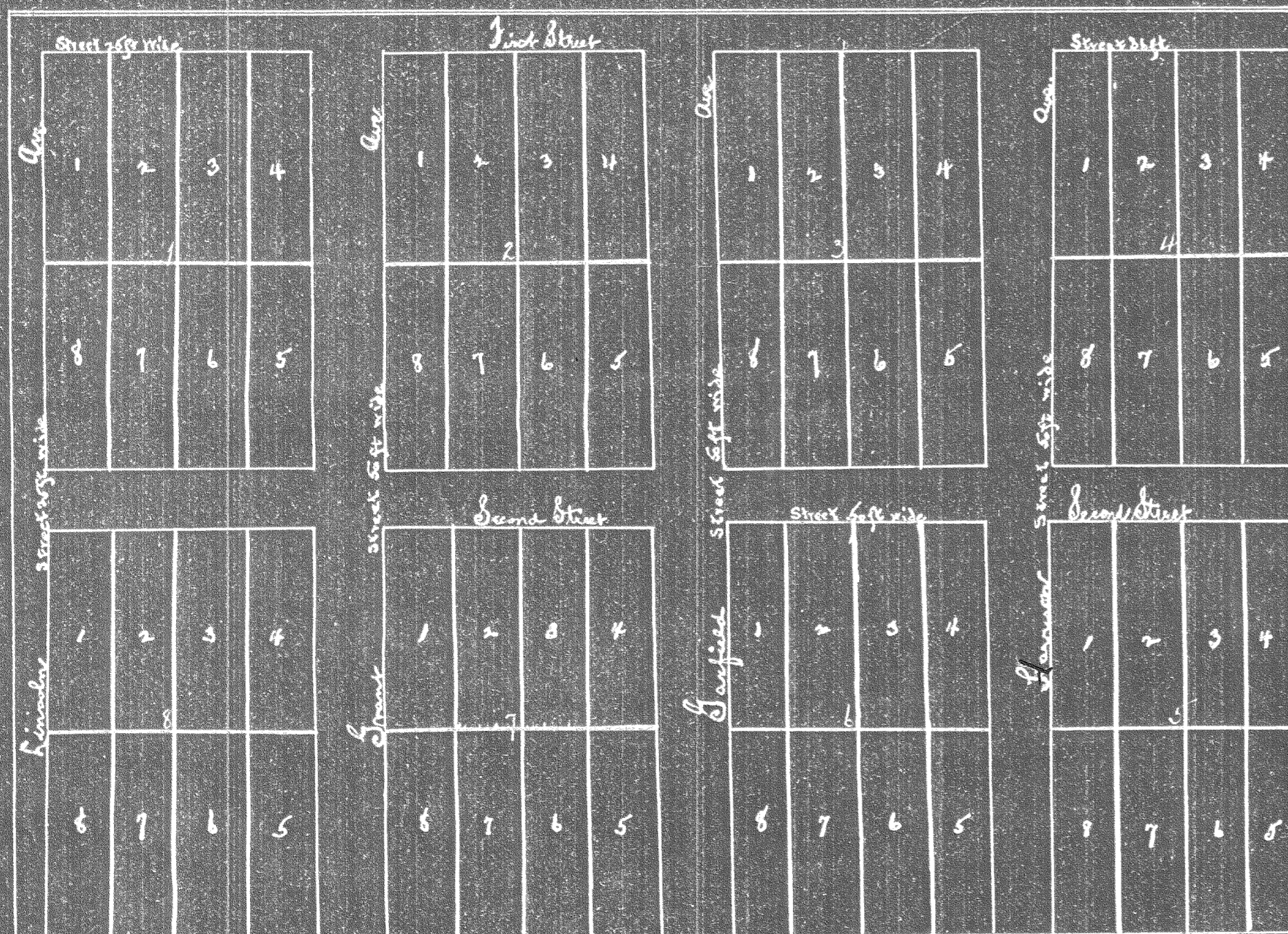
