



Plat of Townsite of Parkdale

Being R. J. McIsaac Trustee's subdivision of a part of the South West 1/4 of the South East 1/4 of Section 32, Township 1 North Range 10 East T. 20

 I, J. H. West, having been first duly sworn in oath say that I have correctly surveyed and marked with copper monuments the land shown on this plat; that the initial point of said survey is 64 1/2 - 3 1/2 - 133 feet East and Thirty 5307 feet North of the 1/4 Section Corner, or South boundary of Section 32 at Case Line School in Township 1 North Range 10 East T. 20 which point is the South West corner of the lands included in said survey and shown on this plat; that I marked said initial point by setting a galvanized iron pipe 2 1/2 in diameter and 3 feet long 6 inches under the surface of the ground; that this plat is drawn to a scale of 1" equals 100 feet; that said tract is divided into 12 blocks, as shown on this plat and same are numbered 1 to 12 inclusive; blocks numbered 1-2-3-4 contain 12 lots numbered 1-12 inclusive; block 5 contains 4 lots numbered 13-16 inclusive; block 6 contains 5 lots numbered 17-21 inclusive; that each of said lots is 50,000 feet except where otherwise indicated on fractional lines on the plat; that all streets and roads shown on said plat are 40 feet wide and that I marked on ground the corner of each lot and block by a stake not less than 2" square driven securely in the ground.
 Said survey was commenced on the 30 day of April, 1910 and finished on the 6th day of May 1910
