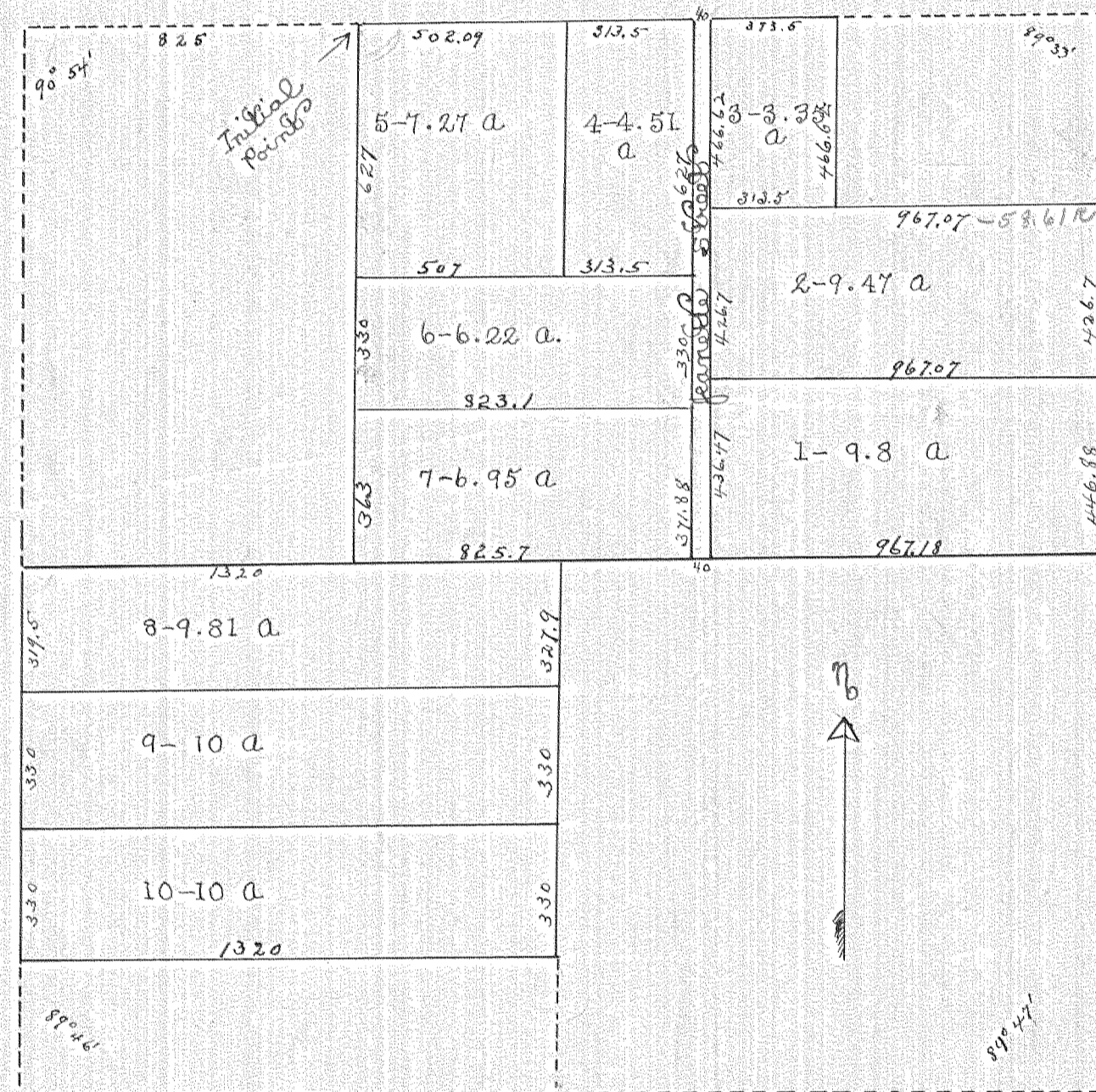


"Highland"

 Dedication and Plat.
 Filed for Record Sept. 6th, 1904, at 8 A.M.
 Newton Clark and Mary H. Clark, husband and wife, to the public, Plat and Dedication of "Highland".

Know all men by these presents, That we, Newton Clark and Mary H. Clark, husband and wife, have caused to be surveyed and platted, under the name and title of "Highland" those certain tracts and parcels of land, being a part of the Northwest quarter of section 11, Township two north, range ten east, of Willamette Meridian, in Wasco County, State of Oregon, particularly described, as follows, to-wit:

Beginning at a point on the section line 825 feet east of the Northwest corner of said section 11; thence, angle to the right 90°54' run in a southerly direction 1320 feet thence angle to the right 89°06' run in a westerly direction 825 feet to section line between sections 10 and 11; thence angle to the left 89°46' and run in a southerly direction along section line between sections 10 and 11, 879.5 feet; thence angle to the left 90°14' and run in an easterly direction 1320 feet; thence, angle to the left 89°46' and run in a northerly direction 987.9 feet; thence, angle to the right 90°10' and run in an easterly direction 1337.5 feet; thence angle to the left 90°10' and run in a northerly direction 873.53 feet; thence, angle to the left 90°27' and run in a westerly direction 553.57 feet; thence, angle to the right 90°27' and run in a northerly direction 466.62 feet to the section line between sections 2 and 11; thence angle to the left 90°27' and run in a westerly direction along the section line between said sections 2 and 11, 1169.09 feet to the point of beginning, containing 77.38 acres, more or less. Said tract is subdivided into 10 lots, numbered from one to ten, both numbers included and each of said lots contains the number of acres following, to-wit: Lot 4, 4.51 acres;

Lot 1, 9.8 acres, Lot 2, 9.47 acres, Lot 3, 3.25 acres, Lot 5, 7.27 acres, Lot 6, 6.22 acres, Lot 7, 6.95 acres, Lot 8, 9.81 acres, Lot 9, 10 acres, and Lot 10, 10 acres, and we hereby declare the annexed map to be a true and correct plat of said subdivision; and we hereby dedicate to the use of the public forever as a public way, Jeanette Street, as the said street is shown on said map and plat.
