DATES PERFORMED: Summer, 1968; Spring 1969

The survey of Section 6 was to establish the boundary of Panorama Point. This job was started in late Summer of 1968 and finished in the early Spring of 1969. An attempt was made to set the 1/16<sup>th</sup> corners from this survey but most traverse points were in cultivated land and had been destroyed when the offsets were made; therefore only the South, Southwest 1/16<sup>th</sup> corner was set from this survey. The center of the section was set with a 2 inch iron pipe with an Oak, 24 inches in diameter bearing S 40° W at 47.6 ft. distance, blazed and scribed (Cen. Sec 6 2N 11 E). The West quarter corner was found when the offset was attempted. Being in the center of cultivated land, no accessories were placed, however, an U.S.F.S. location poster was placed on a power pole bearing S 12° W at a distance of 65.0 feet from the 1-1/2 inch iron pipe, which is accepted as the quarter corner.

Monuments found and set, together with the measured distances and bearings used on this survey, are shown on the attached map, which is by reference made a part of these notes.

Resume': Panorama Point Survey in Section 6 T 2 N, R 11 EWM

This survey was initiated at the request of Roy Webster, through the Hood River County Executive, to have the West line of Panorama Point set so that he could plant some redwood trees on his property along this line.

The West quarter corner of Section 6 was missing and the center of the section was in question. The survey crew ran the following lines to prove this section and set the line between the County and Roy Webster.

1. West line of Section 6
2. North line of Section 6
3. South line of Section 6
4. N quarter corner to the S quarter corner
5. West quarter corner to the East Side Grade Road, which line is the South line of Panorama Point.
6. Exterior of Panorama Point Property, consisting of two parcels.
7. The line running North and South between the two parcels of Panorama Point.
8. Set offsets to true line on Panorama Point exterior.

The Cost to the County is as follows:
