Gentlemen:

Regarding our survey in Section 7, Township 2 North, Range 8 East, Willamette Meridian, our job number 69-242. As stated upon our tracing this survey was based on a 1937 survey by Marshall Brothers of Portland. We also used as reference maps, the Columbia River Highway maps of the Oregon State Highway Departments and mile maps 5 and 6 of the Bonneville - The Dalles Power line that were acquired from the Bonneville Power Administration.

Due to the fact that the East one-quarter corner, the South one-quarter corner and the Southeast corner of the Section were not in we followed the procedures outlined in the B.L.M. manual of surveying.

The information on the State Highway Maps and Bonneville Maps were used to fill in the distances not recorded on the Marshall Brothers survey. We did not reference any of our corners, but could replace them from traverse ties or from ties to the B.P.A Lines.
