Branton, registered professional engineer for the State of Oregon, being first duly sworn, depose and say that I have correctly surveyed and marked with legal monuments the land represented on the annexed plat of Linville Subdivision in Hood River County, Oregon, that a 2"X36" galvanized iron pipe was set at the initial point of said survey, said initial point being S0°49'W 70.0 feet from the Section corner common to Sections 15,16,21,22 Twp.2N., Range 10E., WM., Hood River County, Oregon. Said initial point also being on the Northerly R/W line of Hood River Dee Secondary Highway, thence along the arc of a 367.03 foot radius curve to the left 133.35 feet (the chord of which bears S43°26'W 132.68 feet) thence S 33°17'W 94.0 feet; thence along the arc of a 271.56 foot radius curve to the right 187.93 feet (the long chord which bears S53°06'30" W 184.20 feet) thence S72°56'W 8.5 feet; thence along the arc of a 2321.83 foot radius curve to the left 271.51 feet (the long chord of which bears S69°35'W 271.35 feet) thence S66°14'W 338.60 feet; thence along the arc of a 788.51 foot radius curve to the right 191.29 feet (the long chord of which bears S73°11'W 190.82 feet) thence S80°08' W 130.97 feet; thence along the arc of a 602.96 foot radius curve to the left 125.41 feet (the long chord of which bears S74°10'30"W 125.19 feet) thence S68°13'W

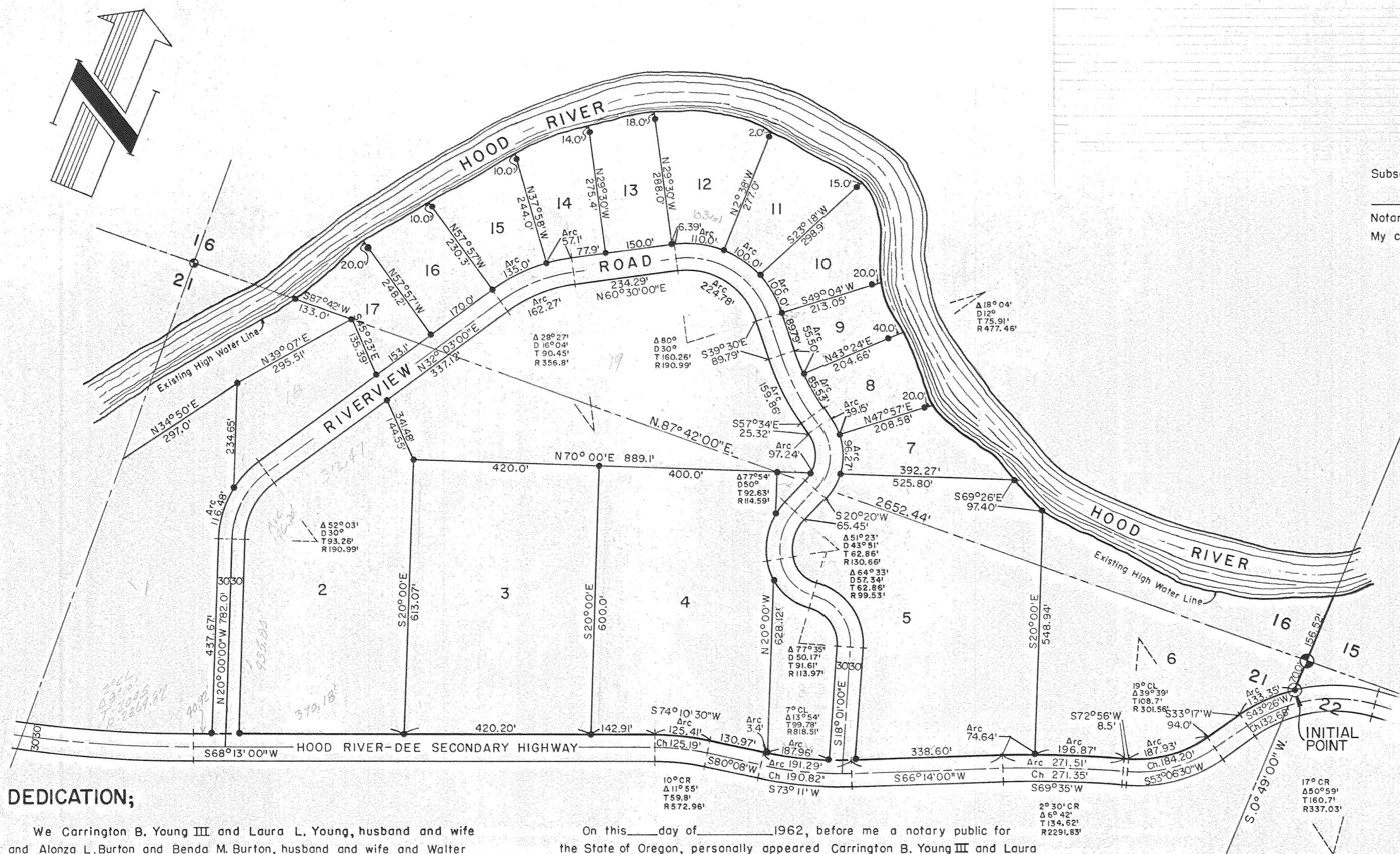
