DATE COMPLETED: April 13, 1971

On April 7, 1971 our firm was retained by Mr. Charles Edwards to survey and set the corners of three parcels of land situated immediately south of, and in one instance adjacent to, the Dethman Ridge Road. One parcel was surveyed as per legal Description supplied by Mr Edwards. The boundarys of the remaining two parcels were shown to us by Mr. Edwards and a metes and bounds survey was initiated and legal descriptions were prepared.

The survey was begun by researching the county survey records for any available data pertinent to the project. Obtained were a plat by Mart Perkins (11-8-57) and corner references, section diagrams and field notes by Hood River County. The corners found and used during this survey were the corner common to Sections 13, 14, 23, and 24, the one-quarter section corner common to sections 14 and 23 and the East one-sixteenth section corner common to sections 14 and 23.

Bearing control used throughout this survey was extended from the North line of Section 23 which is based on assumed West.

All corners found and established during the course of this survey together with measured angles and distances are shown on the attached map, which by reference is made a part hereof.
