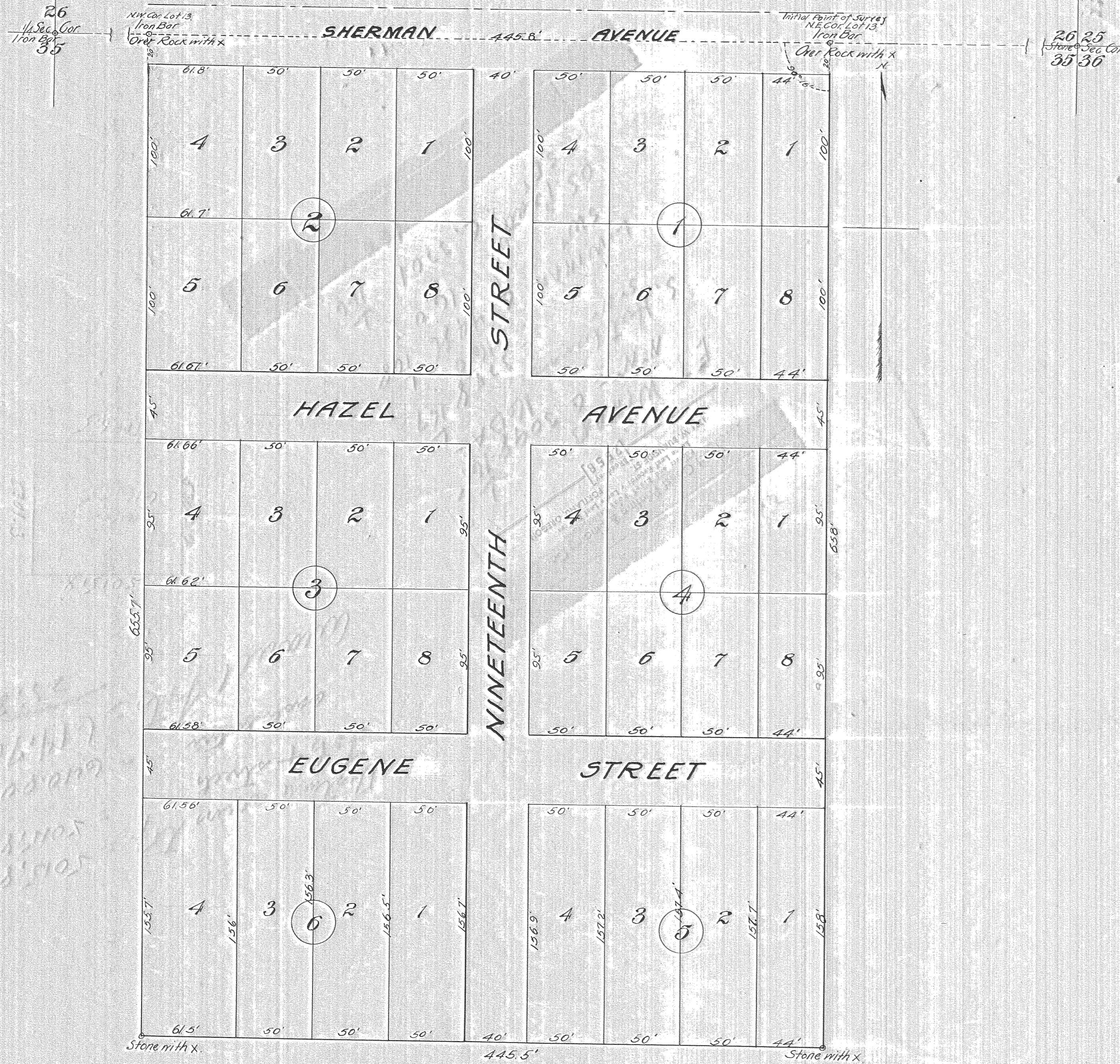


PLAT OF COLUMBIA PARK AN ADDITION TO THE CITY OF HOOD RIVER
