


Plat



This is to certify that Deadpoint Improvement Company is the owner of the Land situated in the County of Wasco and State of Oregon, and known and described upon the United States Plats and surveys as: The North-West quarter, the North half of the North-east quarter, and the North half of the South-west quarter, all in Section Thirty-six (36) in Township Two, North of Range Nine East of the Willamette Meridian, containing 320 acres, more or less. That the said Deadpoint Improvement company is a corporation existing under and by virtue of the Laws of the State of Oregon, and Domiciled in the City of Hood River, therein, that said corporation before desirous of plating said land into acre Lots, has caused this "Plat" of Forsythe to be made after surveys made by John Leland Henderson Surveyor and does hereby dedicate this Plat of Forsythe, dedicating to the use of the public forever all the Roads as marked out on said Plat, and more particularly described in the legend hereto and hereinafter written,

Hibbard as president and he the said John Leland Henderson as Secretary of Deadpoint Improvement Company executed the foregoing instrument and the seal affixed to the Plat of "Forsythe" as and for the act and deed of said Corporation freely and voluntarily, and in accordance with their respective powers thereon mentioned, and he the said John Leland Henderson, being to me also known and acknowledged by me that he is the Secretary of the said Corporation, and resides at Hood River, Oregon, and that he is the true subscriber, and is acquainted with, and has in his possession the instrument and the seal affixed thereto, and I am further informed and believe that the seal affixed to the foregoing instrument and the seal affixed to the Plat of "Forsythe" as and for the act and deed of said Corporation freely and voluntarily, and in accordance with their respective powers thereon mentioned, and that he signed his name thereto by the like order of the Board of Directors of said Company, and that he signed his name thereto by the like order of the Directors of said Company.

Subdivision of the North-west quarter, the North half of the North-east quarter, and the North half of the South-west quarter in Section Thirty Six in Township 2 North of Range 9 East W.M. in Wasco County Oregon, containing 320 acres, more or less, into Lots, each containing 10 acres more or less.

I, John Leland Henderson, Surveyor do certify that the following LEGEND is correct as I verily believe: The Land platted is divided into 32 Lots, numbered from 1 to 32 inclusive. The areas in acres, the lengths of lines, angles, courses and distances are marked on the plat the Meridian from which all calculations and angles are made and measured, is the section line between the North half of section 36 and 36 T. 2 N.R. 9 E.W.M. all exterior Roads are 20 feet wide, all interior Roads are 10 feet wide, the exterior Roads take 20 ft off of Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22 & 33, on the Interior Roads the lot lines of lots of all Lots bordering on roads lie in center of roads, the scale is 5 chains or 66 feet each to 1 inch, some of the Lots are covered with fine fir timber, the soil is good, many Lots are quite level, some are broken by ravines, There are five Springs on the Land, the Company's ditch delivers about 75 inches Water 4 miles measurement on the Land. The land is all under the Ditch of Water Supply Co. and all but about 5 acres is under Deadpoint Company's Ditch. The Land platted has all been surveyed by me, with 6 to 8 men aiding, stakes numbered to show the respective Lots have been set up by me at each Lot corner and at Section and 1/4 sec. corners, and at center of Section, the survey was completed May 13, 1905, and the plat below was also made by me.
