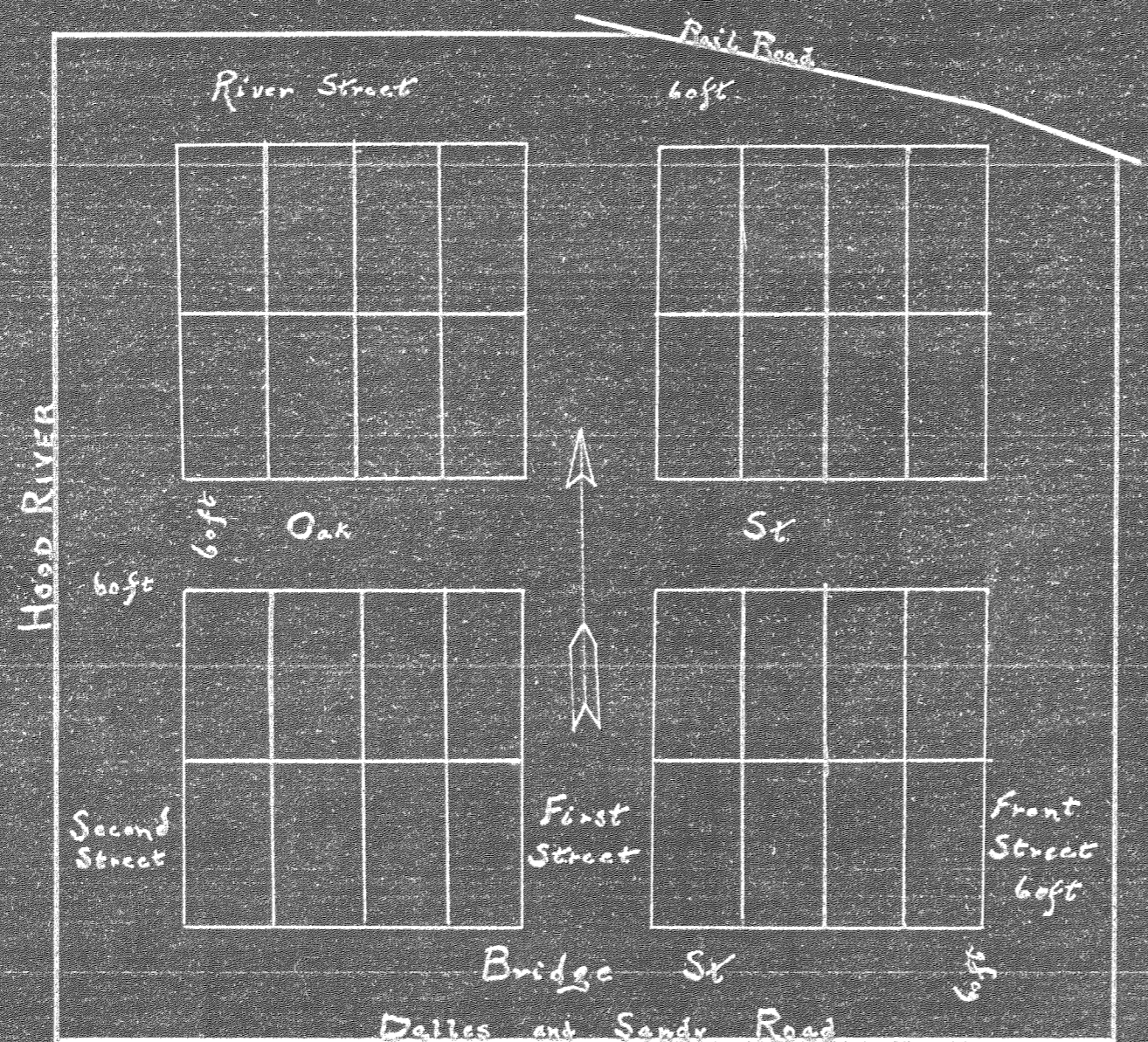


Field Notes of the Survey of the plat of the Village of "Hood River".

Begin on the 1/2 Sec. Cor. common to secs. 25 & 36, Township Three (3) North range Ten (10) East, W.M. thence Var. 20°00' E. East 17.50 chs. to point of intersection with the eastern boundary of N. Coe's Donation Claim, thence North 3.81 chs. at which point I drove an Iron Bar two feet in length, two feet in the earth for the Southeast corner of said village plat, thence West 60 feet, that being the width of a street on the east side of the plat, and set stake for Southeast corner of Lot 8 in Block 4, thence on west side of the street, North 100 feet set post for Cor. to lots 1 and 8 block 4, thence North 100 feet and set post for North east cor of Lot 1 Block 4; thence North 60 feet across street and set post for Cor. to lot 8 Block 1, thence North 100 feet and set post for cor. to lots 1 and 8 block 1; thence North 100 feet and set post for Northeast Cor. to Lot 1 Block 1; thence West 50 feet and set post for Cor. to Lots 1 & 2 Block 1; thence South 100 feet to cor. to lots 1, 2, 7, and 8, block 1; thence South 100 feet to Cor. to Lots 7 and 8 block 1; thence South 60 feet across street to Cor. to Lots 1 & 2 Block 4; thence South 100 feet to Cor. to lots 1, 2, 7, and 8 Block 4; thence South 100 feet to Cor. to lots 7 & 8, block 4; thence West 50 feet to Cor. to lots 6 & 7 Block 4; thence North 100 feet to cor. to lots 2, 3, 6, & 7, Block 4; thence North 100 feet to Cor. to lots 2 & 3, Block 4; thence North 60 feet across street to corner, to lots 6 & 7, Block 4; thence North 100 feet to cor. to lots 2, 3, 6, and 7 Block 1; thence West 100 feet to Cor. to Lots 2 & 3, Block 1; thence West 50 feet to Cor. to Lots 3 & 4 Block 1; thence South 100 feet to Cor. to Lots 3, 4, 5, & 6 Block 1; thence South 100 feet to Cor. to lots 5 & 6 Block 1; thence South 60 feet across street to cor. to lots 3 & 4 Block 4; thence South 100 feet to cor. to lots 3, 4, 5, and 6 block 4; thence South 100 feet to cor. to lots 5 & 6, Block 4; thence West 50 feet to Southwest Cor. of Lot 5, Block 4; thence North 100 feet to Cor. to lots 4 & 5, block 4; thence North 100 feet to Northwest cor. of Lot, 4, Block 4; thence North 60 feet across street to southwest cor. to Lot, 5, Block 1; thence North 100 feet to Northwest cor. of lot 4, Block 1; thence West 60 feet across street to Northeast Cor. of lot 1 Block 2; thence South 100 feet to Cor. to lots 1 & 8 Block 2; thence South 100 feet to southeast Cor. of Lot 8 Block 2; thence South 60 feet across street to Northeast Cor. of Lot 1, Block 3; thence South 100 feet to cor. to lots 1 & 8, block 3; thence South 100 feet to Southeast Cor. of lot 8; block 3; thence West 50 feet to Cor. to lots 7 & 8, Block 3; thence North 100 feet to Cor. to Lots 1, 2, 7, & 8 block 3; thence North 100 feet to cor. to lots 1 & 2 Block 3; thence North 60 feet across street to cor. to lots 7 & 8 block 2; thence North 100 feet to cor. to lots 1, 2, 7, & 8, Block 2; thence North 100 feet to cor. to lots 1 & 2 Block 2; thence West 50 feet to Cor. to lots 2 & 3 block 2; thence South 100 feet to cor. to Lots 2, 3, 6, & 7, block 2; thence South 100 feet to cor. to lots 6 & 7 Block 2; thence South 60 feet across street to cor. to lots 2 & 3 block 3; thence South 100 feet to Cor. at lots 2, 3, 6, & 7, Block 3; thence South 100 feet to cor. to lots 6 & 7, Block 3; thence West 50 feet to Cor. to lots 5 & 6 block 3; thence North 100 feet to Cor. to lots 3, 4, 5, & 6 Block 3; thence North 100 feet to cor. to lots 3 & 4 Block 3; thence North 60 feet across street to cor. to lots 5 & 6, block 2; thence North 100 feet to cor. to lots 3 & 4, block 2; thence West 50 feet to Northwest cor. of Lot 4 Block 2; thence North 60 feet, thence West 60 feet to set a post at the angle or corner of the two streets running East and West and North and South; Then returning to Northwest corner of lot 4, block 2 I run, South 100 feet to cor. to lots 4 & 5, block 2; thence South 100 feet to Southwest Cor. of Lot 5 Block 2; thence South 60 feet across street to Northwest cor lot 4, block 3; thence South 100 feet to cor. of lots 4 & 5 block 3; thence South 100 feet to Southwest Cor. of lot 5, block 3; thence West 60 feet to establish stake on west side of the street at its intersection with The Dalles & Sandy Wagon Road which bounds the plat on the South side.

Coe, freely and voluntarily and for the uses and purposes of a town site and that he had named the same Hood River and for which purpose the same shall forever hereafter be donated.
