



Plat of First Addition to Riverside Park

Being the Oregon Lumber Company's subdivisions of all of Section Twelve (12) Township One (1) North Range Nine (9) East of the Willamette Meridian, in Hood River County, State of Oregon.

I, J. H. West, having been first duly sworn, on oath, say that I have correctly surveyed and marked with proper monuments the land shown on this plat; that the initial point of said survey is two and one half (2 1/2) feet south and two (2) feet east from the North East corner of Section (12) Township One (1) North, Range Nine (9) East of the Willamette Meridian (said corner is established by order of Court of Hood County, June 10th, 1908 by Shank, Moss and Brit-Sumner); which point is the North East corner of the lands included in said survey and shown on this plat; that I marked the central point by setting a galvanized iron pipe in diameter and 3 feet long 6 inches under the surface of the ground; that this plat is drawn to a scale of 1" equals 200 feet; that said tract is divided into lots as shown on this plat and same are numbered from 1 to 64 inclusive; that the number of acres in each lot and dimensions is marked on each lot; and all streets and roads shown on said plat are 20 feet wide and that I marked on the ground the corner of each lot by a stake, not less than 5 inches in diameter, driven securely in the ground and on the side of each stake being the number of the lot.

Said survey was commenced on the 16th day of April, 1911 and finished on the 10th day of June, 1911.
