


N.W. CORNER



NARRATIVE


THIS SURVEY WAS DONE IN ORDER TO LOCATE THE EXISTING R/W OF A PORTION OF DETHMAN RIDGE DRIVE AND ALSO TO LOCATE AND MONUMENT ADDITIONAL R/W NEEDED TO RECONSTRUCT THIS PORTION OF THE ROAD. THE EXISTING R/W WAS ACQUIRED BY HOOD RIVER COUNTY IN 1950 AND 1951 (SEE INSTRUMENT NO. 5 7700, 7911, 7877, HOOD RIVER COUNTY DEED RECORDS). A COUNTY ENGINEER'S DRAWING DATED OCTOBER 31, 1950 WAS USED BY THE HOOD RIVER COUNTY SURVEY DEPT. IN 1986 TO LOCATE THE EXISTING R/W. THIS 1950 DRAWING WAS BASED ON THE THREE DEEDS HERE TO FORE MENTIONED, AND WAS FOUND TO FIT THE EXISTING ROAD BED VERY CLOSELY. THE ADDITIONAL R/W TAKINGS WERE MONUMENTED WITH 1/8" IRON RODS WITH RED PLASTIC CAPS MARKED "COUNTY SURVEYOR".
