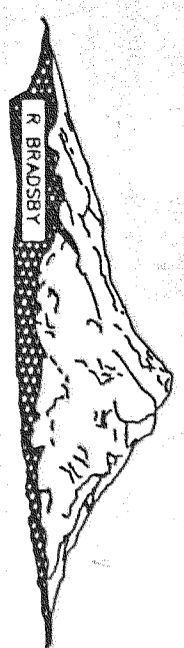

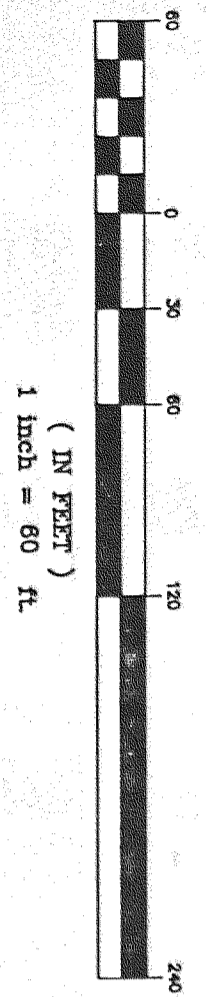

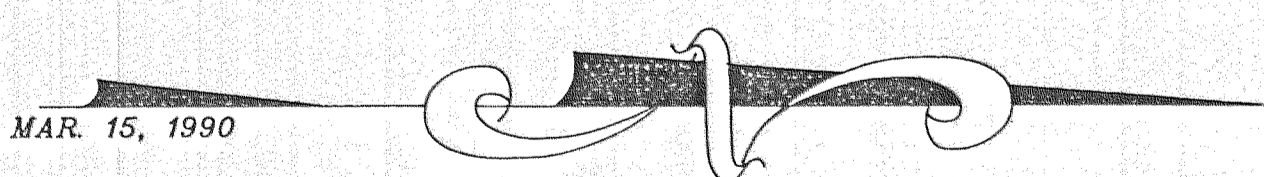
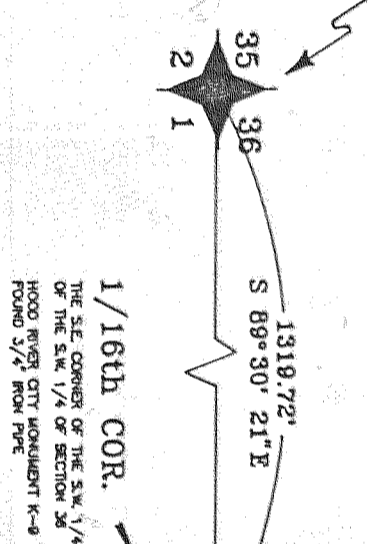


GRAPHIC SCALE
