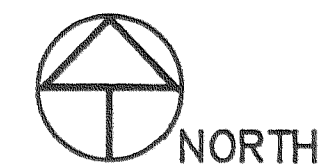
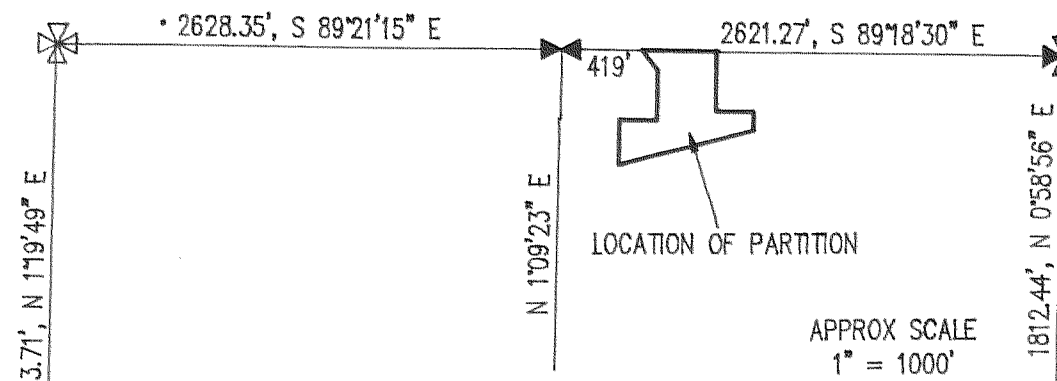

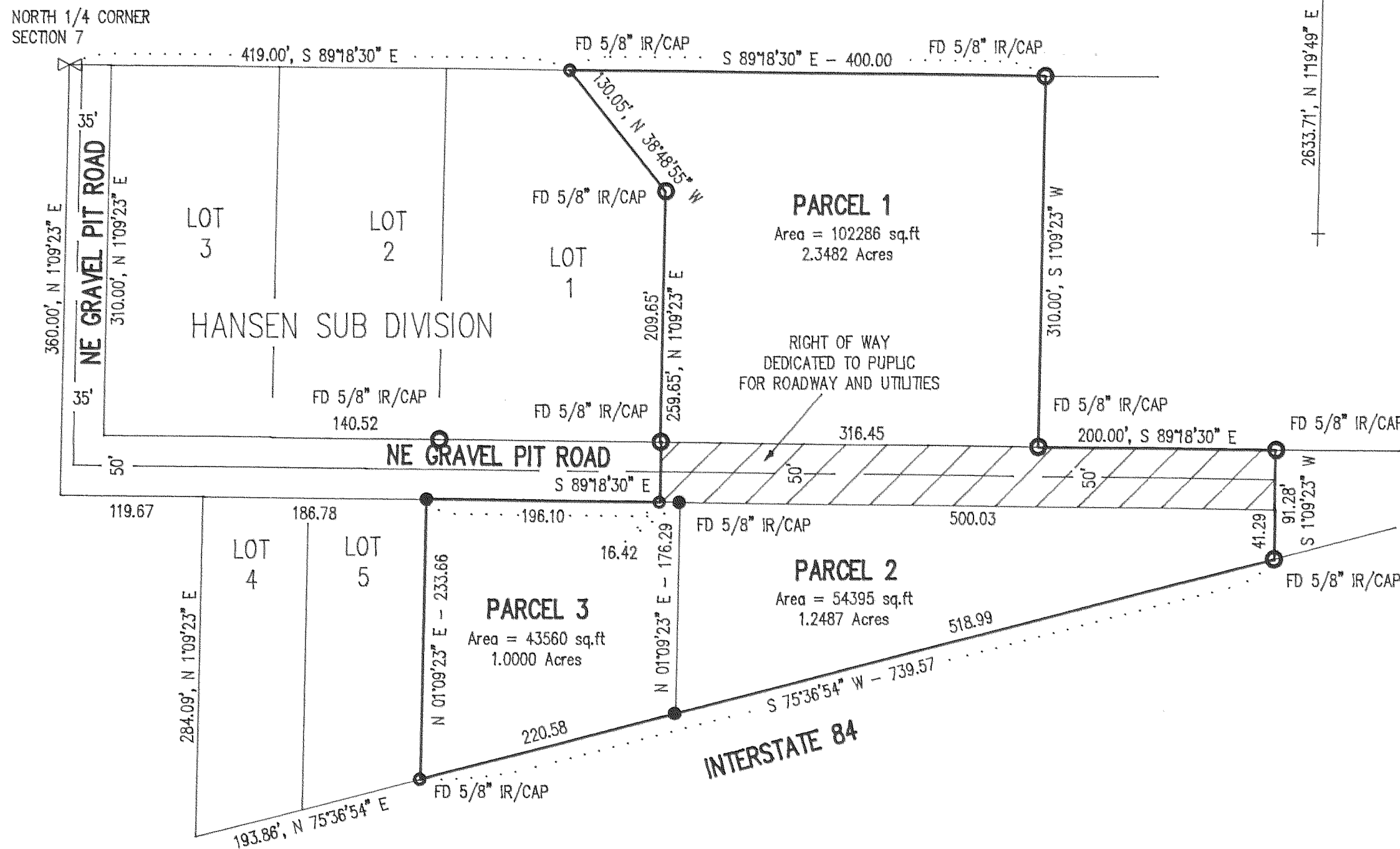


PARTITION IN THE

ALSO I SURVEYED A PARTITION FOR MARY HANSEN IN DECEMBER OF 1991 AND THE HANSEN ADDITION IN SEPTEMBER OF 1991 WHICH ESTABLISHED THE BOUNDARYS FOR THIS PARTITION. ALL MONUMENTS FOUND AND ESTABLISHED ALONG WITH THE MEASURED BEARINGS AND DISTANCES ARE SHOWN HEREIN.
