I, ROY O. GAYLORD, REGISTERED LAND SURVEYOR FOR THE STATE OF OREGON, BEING FIRST DULY SWORN, DEPOSE AND SAY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH LEGAL MONUMENTS THE LAND REPRESENTED ON THE PLAT OF "FRANKTON PARK PHASE 1" HOOD RIVER COUNTY, STATE OF OREGON; A PARCEL OF LAND LOCATED IN THE NORTHWEST QUARTER OF SECTION 34, TOWNSHIP 3 NORTH, RANGE 10 EAST, WILLAMETTE MERIDIAN IN THE COUNTY OF HOOD RIVER, AND STATE OF OREGON, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT A POINT 660 FEET SOUTH OF THE NORTH QUARTER SECTION CORNER OF SAID SECTION 34, AND WHICH POINT IS AT THE INTERSECTION OF THE EAST LINE OF THE NORTHWEST QUARTER OF SAID SECTION 34 WITH THE CENTERLINE OF DAVENPORT LANE; THENCE (SOUTH) SOUTH 00" 32' 13" WEST ALONG THE EAST LINE OF THE NORTHWEST QUARTER OF SAID SECTION 34 A DISTANCE OF 270.02 FEET TO THE POINT OF BEGINNING OF THE FOLLOWING DESCRIBED PARCEL:


