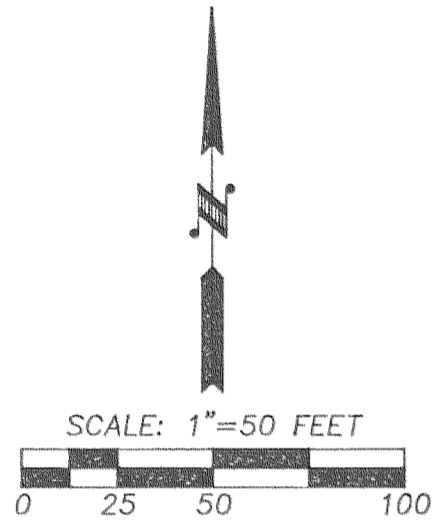

NARRATIVE:

NO MAJOR DISCREPANCIES WERE FOUND. ALL LOTS ARE PLATTED AT 25' WIDTH. ALL PLATTED LOTS AND STREET WIDTHS WERE PROPORTIONED AGAINST THE MEASURED DISTANCE.

THE OLD COLUMBIA RIVER HIGHWAY (CASCADE AVENUE) WAS MEASURED TO THE CENTER LINE AND THE 60 FOOT RIGHT OF WAY WAS ESTABLISHED FROM THESE MEASUREMENTS.
