

NARRATIVE OF SURVEY

THE PURPOSE OF THIS SURVEY IS TO DIVIDE THE PARCEL SHOWN HEREIN INTO TWO SEPERATE LOTS. TWO SURVEY'S WERE USED BY DLC SURVEYING CS #95050 & CS #78017. CS #78017 USED THE EAST 1/4 CORNER PRIOR TO THE RESTABLISHING OF EAST 1/4, CORNER BY THE COUNTY SURVEYOR. THE DEED CALL FOR SET 1/2" IRON RODS AS APPARENT TO CS #78017 AND A SEARCH WAS MADE TO LOCATE THE IRON RODS. (REF.1) AND (REF.2) WERE FOUND AND HELD FOR THE DEED CALLS. (REF.3) WAS THEN CALCULATED BASED ON THE LOCATION OF THE TWO FOUND IRON RODS, THE POSITION ALSO FIT THE EXISTING FENCE LINE.
