 FOUND CORNERS WERE ACCEPTED AND USED AS SHOWN.

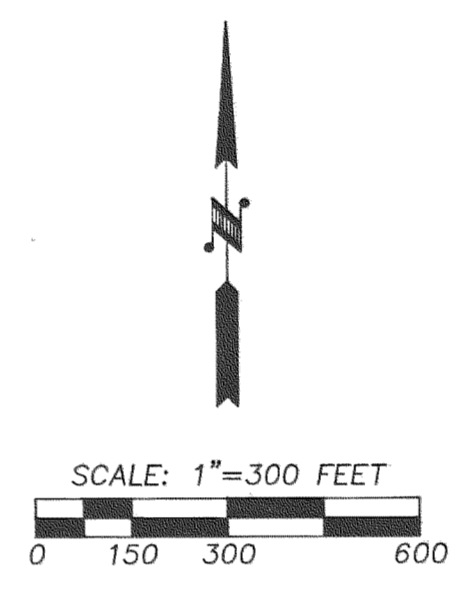


