
### NARRATIVE:

THE PURPOSE OF THIS SURVEY WAS TO DEFINE THE PROPERTY BOUNDARY OF TAX LOT 10901 FROM ASSESSORS MAP 3N-10-36BB AND TO PARTITION IT INTO 2 NEW PARCELS WITH THE COMMON BOUNDARY BEING THE CENTER OF THE COMMON WALL OF THE NEWLY CONSTRUCTED TOWNHOUSE ON THE SUBJECT PROPERTY.

NO MAJOR DISCREPANCIES WERE FOUND.


