

## NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO MONUMENT THE LINES AND FILE FOR RECORD A PARTITION OF THAT TRACT OF LAND DESCRIBED IN MEMORANDUM OF CONTRACT SALE RECORDED AS FEE NO. 952970. THE TRACT IS ALSO DESCRIBED AS TAX LOT 402, IN 10 22, MONUMENTS WERE RECOVERED FROM CS# 95110 WHICH HAD PREVIOUSLY ESTABLISHED THE EXTERIOR BOUNDARIES OF THE TRACT. THE PARTITION LINE WAS ESTABLISHED SO AS TO CREATE TWO 2.5 ACRE TRACTS.


