

NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO ADJUST THE PROPERTY LINE BETWEEN TAX LOT 9100 AND TAX LOT 10200 OF HOOD RIVER COUNTY ASSESSORS MAP 3N-10-25CC AS SHOWN. MONUMENTS OF RECORD WERE FOUND AT THE NORTHEAST CORNER OF BLOCK 1 OF THE AMENDED PLAT OF IDLEWILD ADDITION AND AT THE NORTHWEST CORNER OF BLOCK 3 OF THE RIVERVIEW PARK ADDITION. THE PLS 932 MONUMENT SET FOR C.S.2003022 WAS FOUND TO BE CLOSE TO THE LINE BETWEEN THESE TWO MONUMENTS AND WAS ACCEPTED AS BEING ON THE NORTH LINE OF BLOCK 2 OF RIVERVIEW PARK ADDITION AND AT THE NORTHEAST CORNER OF THE RECENTLY ADJUSTED TAX LOT 9100. THE PLS 932 MONUMENT FOUND AT THE SOUTHEAST CORNER OF TAX LOT 9100 WAS ACCEPTED AS IT CONFORMED WITH THE DIRECTION BETWEEN THE MONUMENTS FOUND ON THE WEST LINE OF BLOCK 3 OF RIVERVIEW PARK ADDITION, IT ALSO WAS CLOSE TO THE DEED DISTANCE FROM THE NORTHEAST CORNER OF TAX LOT 9100. THE SOUTHWEST CORNER OF TAX LOT 9100 WAS CALCULATED AS SHOWN BY HOLDING THE PLAT AND DEED DISTANCES FOR IT'S SOUTH AND WEST LINES. THE SOUTH LINE OF BLOCK 2 OF RIVERVIEW PARK ADDITION WAS CALCULATED FROM THE ORIGINAL PLAT DISTANCES. A MONUMENT FOUND ON THE SOUTH RIGHT OF WAY LINE OF OAK STREET CONFORMED WITH THE RIGHT OF WAY WIDTH. NEW MONUMENTS WERE THEN SET TO ADJUST THE LINE BETWEEN TAX LOT 9100 AND TAX LOT 10200 FOR A DISTANCE OF 47.00 FEET ALONG THE THE EXISTING FENCELINE AS DIRECTED BY THE CLIENT.




