



NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO PARTITION TAX LOT 6400 INTO TWO PARCELS. THE BOUNDARY LINE OF THE ORIGINAL PARCEL 6400 WAS DETERMINED BY USING FOUND MONUMENTS OF RECORD AND PROPORTIONING DISTANCES TO REESTABLISH MISSING

THE SHOWN FOUND MONUMENTS ACCEPTED APPEAR TO CORRECTLY REPRESENT THE CLIENT'S PROPERTY AS DESCRIBED BY LEGAL DESCRIPTION PROVIDED BY THE CLIENT. THE 1" IRON PIPE ON THE EAST LINE OF SUBJECT PARCEL WAS NOT ACCEPTED FOR 2 REASONS. ONE, I WAS UNABLE TO LOCATE A SURVEY OF RECORD INDICATING HOW THE PIPE WAS SET. TWO, IN MY OPINION, THE PIPE WAS OUT OF POSITION FAR ENOUGH RELATIVE TO OTHER FOUND MONUMENTS TO BE UNACCEPTABLE FOR THE PURPOSE OF

THE FOLLOWING LEGAL DESCRIPTIONS WERE PROVIDED TO SHOW NO DEED GAPS OR OVERLAPS EXIST WITHIN THE DEED DESCRIPTION OF THE ADJOINING PARCEL OF LAND TO

THE DEED FINAL DESCRIPTIONS FOR THE PARTITIONED PARCELS WILL BE PARCEL 1 AND 2 OF THE PARTITION PLAT. THE DESCRIPTIONS SHOWN BELOW ARE FOR REFERENCE

NO MAJOR DISCREPANCIES WERE FOUND THOUGH SOME OF THE MEASURED - DEED DISTANCES WERE ALMOST EXCESSIVE.

PARCEL 1: SOUTH 20 FEET OF LOTS 12 & 13; THE SOUTH 20 FEET OF THE WEST 24 FEET OF LOT 11 AND ALL OF LOTS 14, 15 AND THE WEST 24 FEET OF LOT 16 EXCEPTING THE SOUTH 50.5 FEET OF AFORESAID LOTS 14, 15 AND THE PORTION OF 16; ALL IN THE BLOCK 35, HOOD RIVER PROPER, SECTION 36, TOWNSHIP 3 NORTH, RANGE 10 EAST, IN THE CITY OF HOOD RIVER, COUNTY OF HOOD RIVER AND STATE OF OREGON.

PARCEL 2: SOUTH 50.5 FEET OF LOTS 14 & 15; AND THE SOUTH 50.5 FEET OF THE WEST 24 FEET OF LOT 16, ALL IN BLOCK 35, HOOD RIVER PROPER, SECTION 36, TOWNSHIP 3 NORTH, RANGE 10 EAST, WM., IN THE CITY OF HOOD RIVER, COUNTY OF HOOD RIVER AND THE STATE OF OREGON.
