NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO ESTABLISH THE ADJUSTED LINE OF A PROPOSED PROPERTY LINE ADJUSTMENT BETWEEN THOSE TRACTS OF LAND DESCRIBED AS PARCELS 1 AND 2 IN INSTRUMENT RECORDED JANUARY 31, 1995 AS FEE NO. 950375. THE WEST LINE OF THE EXISTING TRACTS WAS ESTABLISHED ALONG THE WEST LINE OF THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 36 AS PER DEED. SAID WEST QUARTER-QUARTER LINE WAS ESTABLISHED BY HOLDING THE IRON PIPE FOUND AT THE NORTHWEST CORNER THEREOF AND AN IRON PIPE AT THE NORTHWEST CORNER OF THE EXISTING TRACTS. THE EAST LINE OF THE EXISTING TRACTS WAS ESTABLISHED PARALLEL WITH THE WEST LINE OF THE QUARTER-QUARTER AS PER DEED. THE DIRECTION OF THE NORTH LINE OF SAID QUARTER- QUARTER WAS ESTABLISHED AT RECORD ANGLE FROM THE WEST LINE. THE NORTH AND SOUTH LINES OF THE EXISTING TRACTS WERE ESTABLISHED PARALLEL WITH THE NORTH LINE OF SAID QUARTER-QUARTER. THE FOUND IRON PIPE WAS ACCEPTED TO ESTABLISH THE NORTHWEST CORNER OF THE EXISTING TRACTS. SAID IRON PIPE IS WITHIN 0.3 FEET OF DEED DISTANCE SOUTH FROM THE NORTHWEST CORNER OF THE QUARTER-QUARTER. THE NORTHEAST CORNER OF THE EXISTING TRACTS WAS ESTABLISHED AT DEED DISTANCE FROM THE NORTHWEST CORNER. THE SOUTHWEST CORNER OF THE EXISTING TRACTS WAS ESTABLISHED AT DEED DISTANCE SOUTH FROM THE NORTHWEST CORNER OF THE QUARTER-QUARTER. FALLINGS ARE SHOWN TO A FOUND BRASS WASHER. THE SOUTHEAST CORNER OF THE EXISTING TRACTS WAS ESTABLISHED AT DEED DISTANCE FROM THE SOUTHWEST CORNER. THE ADJUSTED LINE WAS ESTABLISHED AS THE SOUTHERLY 107.00 FEET (AS MEASURED ALONG THE WEST LINE) OF THE EXISTING TRACTS AS PER CLIENT INSTRUCTION.
