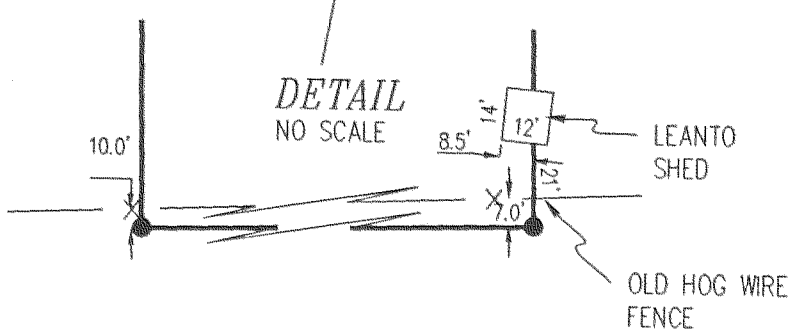
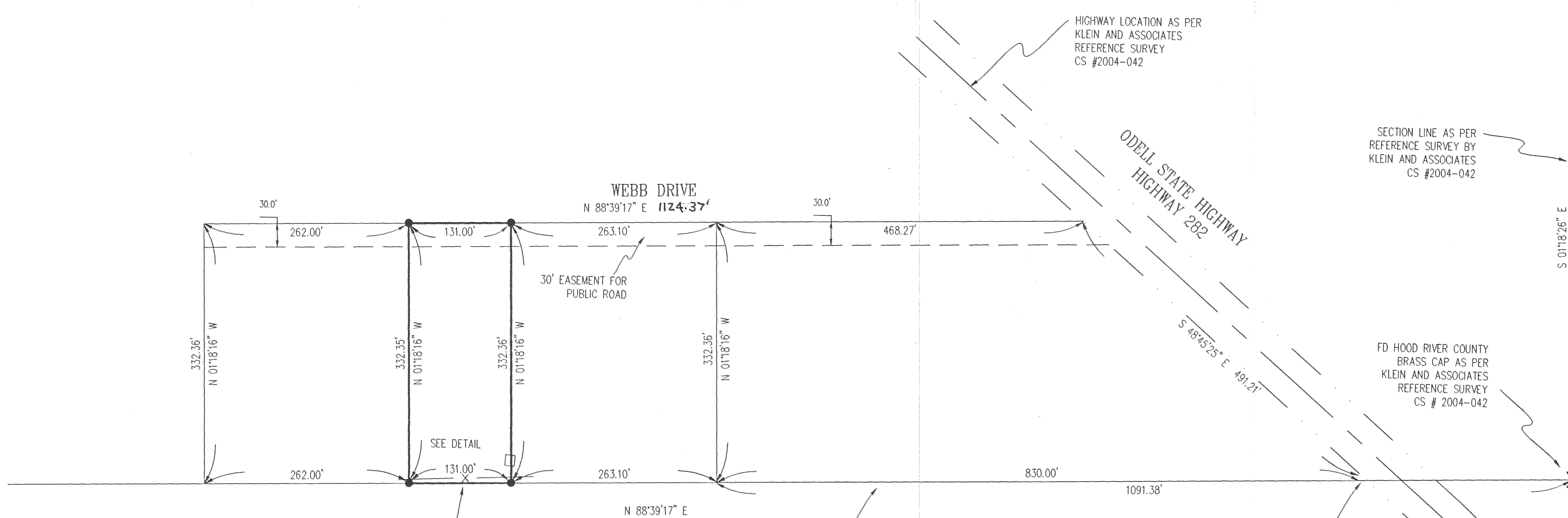

**NARRATIVE OF SURVEY**

THE PURPOSE OF THIS SURVEY WAS TO ESTABLISH THE BOUNDARIES OF THE ABOVE SHOWN PARCEL AND SET MONUMENTS AT THE CORNERS. THE LEGAL DESCRIPTION CALLS TO THE WEST LINE OF THE ODELL HIGHWAY. A REFERENCE SURVEY FOR THE ODELL STATE HIGHWAY (HIGHWAY 282) WAS DONE IN CONJUNCTION WITH THIS SURVEY AND USED AS A REFERENCE FOR THIS SURVEY (CS #2004-042). INCROACHMENTS ARE SHOWN HEREIN.

A SURVEY BY GLEN STRAIT (CS #1411) WAS DONE 1968 OF THE ADJOINING PARCEL AND THE MONUMENTS WERE SEARCHED FOR BUT WERE NOT FOUND. THE DEED CALLS FOR THE PROPERTY LINES TO BE PARALLEL WITH THE SOUTH LINE OF THE NORTHEAST QUARTER AND THE EAST LINE OF THE SECTION.

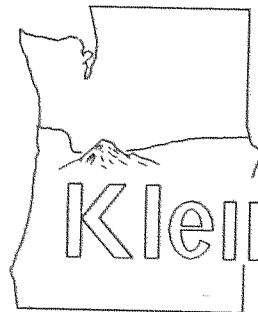
