



**NARRATIVE:**

THE PURPOSE OF THIS SURVEY WAS TO RE-SURVEY OF THE COUNTY SURVEYOR'S SURVEY No. (C.S. #) 85050 FOR FINLEY H. McNAUGHTON AND LOCATE THE REVISED PROPERTY BOUNDARY OF TAX LOT 200. 5/8" X 30" IRON RODS WERE SET AT ALL OF THE PROPERTY CORNERS.

TERRA SURVEYING COMPLETED SURVEYS FOR ROBERT MARSH AND FINLEY McNAUGHTON IN 1984 AND 1985. THE CONTROLLING CORNERS AT THAT TIME WERE USED TO SUBDIVIDE THE QUARTER SECTION SINCE THE HOOD RIVER COUNTY SURVEYOR HAD USED THEM FOR A SURVEY OF THE SOUTH HALF OF THE SECTION IN 1975. A DIFFERENT COUNTY SURVEYOR DECIDED IN 1988 THE NORTH QUARTER CORNER WAS INCORRECT AND NEEDED TO BE MOVED. THE RELOCATION MOVED THE NORTH-SOUTH CENTER OF SECTION, THE CENTER OF SECTION AND THE NORTH-SOUTH 1/16 LINES. THE COUNTY DID NOT FILE A RE-SURVEY OF THEIR 1975 SURVEY. PLEASE REFER TO THE C.S. # 85050 SURVEY FOR ADDITIONAL NARRATIVE NOTES. THE SURVEY IN MAY, 2003 FOR LEE MOORE, C.S. # 204059, HAS THE SAME BASIS OF BEARING AS THIS SURVEY. THE SECTION BREAKDOWN OF THAT SURVEY WAS USED TO COMPLETE THIS SURVEY.
