NARRATIVE:


THE PURPOSE OF THIS SURVEY IS TO MONUMENT AND FILE FOR RECORD A PROPERTY LINE ADJUSTMENT BETWEEN THOSE TRACTS OF LAND DESCRIBED IN DEEDS RECORDED AS DOC #732201 AND #900154. EXCEPTING THAT PORTION CONVEYED TO THE STATE OF OREGON BY DEEDS RECORDED AS DOC #930797 AND #930798, THE BOUNDARIES OF GOVERNMENT LOT 14 WERE ESTABLISHED BY SECTION SUBDIVISION HOLDING THE FOUND MONUMENTS AS SHOWN. THE CENTERLINE AND EASTERLY RIGHT OF WAY LINE OF THE MT. HOOD HIGHWAY WAS ESTABLISHED BY HOLDING FOUND MONUMENTS AS SET BY CS 2000 071. THE CENTER OF THE CREEK ESTABLISHES THE WESTERLY LINE OF TAX LOT 1800 AS PER DEED. THE SOUTHEAST CORNER OF TAX LOT 1701 WAS ESTABLISHED AT DEED DISTANCE EAST OF THE INTERSECTION OF THE SOUTH LINE OF THE NORTHEAST QUARTER OF GOV'T LOT 14 WITH THE EASTERLY RIGHT OF WAY LINE OF THE MT HOOD HIGHWAY PRIOR TO ITS RELOCATION. THE EAST LINE OF TAX LOT 1701 WAS ESTABLISHED AT RIGHT ANGLES TO SAID SOUTH LINE. THE DEED CALLS THIS LINE TO BE "NORTH". THE NORTH LINE OF TAX LOT 1701 WAS ESTABLISHED 125 FEET NORTH OF AND PARALLEL WITH THE SOUTH LINE AS PER DEED. THE ADJUSTED LINES WERE ESTABLISHED AS PER CLIENT INSTRUCTION.
