NARRATIVE OF SURVEY

THE PURPOSE OF THIS SURVEY IS TO RETRACE THOSE PARCELS OF OWNERSHIP AS DESCRIBED BY DOCUMENT NO.'S 851079, 20010236, 20052434 AND 20054429 ON FILE IN HOOD RIVER COUNTY, OREGON, AND LOCATED IN THE NORTHEAST QUARTER OF SECTION 34, TOWNSHIP 3 NORTH, RANGE 10 EAST, WILLAMETTE MERIDIAN.

THE NORTH BOUNDARY OF THIS SURVEY WAS ESTABLISHED BY HOLDING THE NORTHEAST SECTION CORNER OF SAID SECTION 34 AND FOUND MONUMENTS BY SURVEYOR NO. 1028 AND NO. 50800 FOUND ALONG THE NORTH BOUNDARY SAID SECTION 34. THE EAST LINE OF THIS SURVEY WAS ESTABLISHED BY HOLDING MONUMENTS SET BY SURVEYOR NO. 50800 ALONG THE WEST BOUNDARY OF FOX HOLLOW SUBDIVISION A SUBDIVISION OF RECORD IN HOOD RIVER COUNTY, OREGON. THE SOUTHEAST CORNER OF THIS SURVEY WAS COMPUTED BY RECORD DIMENSIONS FROM THE 1/16 CORNER FOUND AT THE CENTERLINE OF MAY DRIVE AND 30TH AND A MONUMENT FOUND AT THE CENTERLINE OF MAY DRIVE AND ROCKY ROAD. THE BOUNDARY AROUND TAX LOT 402 WAS ESTABLISHED BY RECORD DISTANCES AND ANGLES FROM SURVEY NO. 1068 A SURVEY ON FILE IN THE HOOD RIVER COUNTY SURVEYORS OFFICE. THE SOUTH BOUNDARY WAS ESTABLISHED BY 20.00 FOOT OFFSETS FROM CENTERLINE MONUMENTS FOUND ALONG MAY STREET. THE EASTERLY BOUNDARY OF THIS SURVEY WAS ESTABLISHED BY HOLDING MONUMENTS OF RECORD AS SHOWN ON THIS SURVEY.
