

NARRATIVE OF SURVEY

THE PURPOSE OF THIS SURVEY IS TO RELOCATE COMMON BOUNDARIES BETWEEN ADJOINING PROPERTIES BY RELOCATING THE SOUTHERLY LINE OF THAT CERTAIN TRACT DESCRIBED BY DOCUMENT NO. 20025801 ON FILE IN HOOD RIVER COUNTY. OREGON, AND LOCATED IN THE NORTHWEST QUARTER OF SECTION 36, TOWNSHIP 3 NORTH, RANGE 10 EAST, WILLAMETTE MERIDIAN.

MONUMENTS WERE FOUND ALONG SHERMAN AVENUE WHICH WERE USED TO COMPUTE THE SHERMAN AVENUE RIGHT-OF-WAY AND THE NORTH LINE OF THAT PARCEL DESCRIBED BY DOCUMENT NO. 20024801. MONUMENTS WERE FOUND ALONG EUGENE AVENUE WHICH WERE USED TO COMPUTE THE EUGENE AVENUE RIGHT-OF-WAY. USING THE ABOVE MENTIONED MONUMENTS THE 11TH STREET RIGHT-OF-WAY WAS COMPUTED WHICH ESTABLISHED THE EAST LINE OF SAID PARCEL. A 3/4" BY 1" IRON BAR WAS FOUND AND HELD AT THE SOUTHWEST CORNER OF SAID PARCEL. THE SOUTHEAST CORNER OF SAID PARCEL WAS COMPUTED BY PROPORTIONAL METHODS AND RECORD DEED CALLS.
